Drone shots of Toronto appear.

## EXT. BAY STREET - DAY

A shot of the street with cars driving by. A grey car drives by.

CUT TO:

### INT. LAW FIRM HALLWAY - DAY

The elevator door opens. Kim exits the elevator smiling, and enters the Gale Law Firm.

## INT. LAW FIRM WAITING ROOM - DAY

Kim walks by the receptionist and catches up with her before continuing to walk to her office.

KIM

Hi! How are you doing?

RECEPTIONIST

I'm good, how are you?

KIM

Good, thanks! I'll see you in a bit.

RECEPTIONST

Sounds good.

# INT. KIM'S OFFICE - DAY

Kim enters her office, puts down her bag and starts looking through her files. "Plays voicemails". She also talks to clients on the phone. Awards and family photos can be seen around her as she works. Malvin or Jessica walks in the room to bring Kim a file. Kim opens the file.

CUT TO:

# INT. BOARDROOM - DAY

Kim closes up the same file in the boardroom. Kim is giving a presentation to young adults. A banner can be seen next to her while she flips through her presentation. All the young adults are listening and taking notes while she speaks.

Malvin and Jessica walk by in the hallway with their clients.

INT. GYM - DAY

Kim is doing Yoga.

INT. WAITING ROOM - DAY

CLIENT is sitting in the waiting room upset and nervous waiting for his appointment with Kim. He sits there looking down at his hands defeated. Kimberly walks into the waiting area towards the client and shakes their hand, they exchange hellos.

KIM

Let's head to my office.

She walks him to her office. Malvin and Jessica can be seen in the meeting room and boardroom meeting with clients. They enter Kim's office and sit down.

KIM

How's your morning going?

CLIENT

It could be better.

KIM

So how can I help you?

Jeremy looks down to his hands and begins to tear up.

CLIENT

My dad just passed away and I am still in the house, but my brother wants to kick me out.

KIM

Kim goes through the process with the client and how she can help- Improvisation. She offers words of comfort and passes them documents. Client listens to Kimberly and thanks her for her help.

CLIENT

Thank you so much for your expertise and helping me through this.

KIM

No problem at all. Kim says any closing remarks. My door is always open.

Kimberly walks her client to the front desk and they shake hands.

CLIENT

Thank you again.

KIM

Of course. I will talk to you soon.

Client exits the office. - Repeat this with 1-2 other actors.

### INT.LAW FIRM WAITING ROOM - DAY

Kim walks over and hands the receptionist a file. The receptionist turns around and files it away. She grabs a folder labeled "The Lawyer's Daily" and lays it out on her desk she opens it up to find prints of the articles.

CUT TO:

## INT. MEETING ROOM - DAY

CU of the articles spread out. PULL BACK to reveal Malvin and Jessica laying out the articles and looking at the article on their computer screen. Kim walks in with coffee for her team. She sits down and they all discuss the previous articles and their plan for the next one.

# INT. KIM'S OFFICE - EVENING

Kim walks to her office. Kim continues to work. In the distance you see the co-workers leaving and turning the lights off in the office. Some of her co-workers come in to say goodbye. Kim continues to work until it begins to get late. Kim places a bunch of files in her purse and walks into the distance and turns off the light. She goes out of focus.
