The company is also authorized to create one or more designated series in accordance with W.S. §17-29-211. Each series may have separate rights, powers, duties, and obligations, and the debts, liabilities, duties, and expenses incurred in respect of a particular series shall be recoverable only from the assets of that series and not from the assets of the DAO as a whole or any other series.  
The management and accounting of each series may be conducted on-chain in accordance with the operating agreement.

**XI. Additional Article:**

Authorizes to act on its behalf the following representatives: 1. PT BINARYX PROTOCOL INDONESIA (NPWP-62.514.207.0-905.000), represented by authorized persons; 2. Kurchenko Oleh, (date of birth:18 Jul 1992, ID: FH769044, date of expiry: 06 Sep 2027); 3. Fedosov Andrii, (date of birth: 03 May 1990, ID: FJ225551, date of expiry: 12 Oct 2027) to act independently of each other, while being solely an authorized representative with the right to: negotiate and conclude any civil law deals on terms at its discretion (e.g., sale, lease, mortgage, rent); make payments on behalf of the company, handle certificates and documents, register and submit all kinds of applications; pay fees; represent and act for the company in public authorities,enterprises, courts; sign contracts and agreements, obtain tax numbers and any permits, create branches and representative offices, and sign necessary documents on their behalf and make other legal action related to management of company`s real estate.
