General Terms & Conditions

Thank you for choosing Benares for your event. All reservations for private rooms, provisional or confirmed, are made upon and are subject to the following Terms and Conditions with no variation accepted unless otherwise agreed in writing with Benares.

Booking

Groups are accommodated in our private and semi private dining rooms only, maximum seating as follows:

•	CHEF'S TABLE (private)	6 seats
•	DOVER ROOM (private)	up to 36 seats
•	BERKELEY ROOM (private)	16 seats
•	BAR/LOUNGE	10 to 40 seats
•	CELLAR ROOM (private)	up to 10 seats

Should your party increase above this capacity, we will seat additional guests on separate tables. Lunch parties may have use of the private dining rooms until 4:30pm.

No Room Hire, Deposit or Minimum Spend required for parties of 9 up to 36 (Excludes December).

The restaurant and/or lounge is available for exclusive hire, costs would be outlined in a proposal.

Menus

We offer a choice of set menus for groups from which a menu must be chosen 2 weeks prior to the booking. Vegetarian menus, special dietary requirements and different spice levels may be accommodated by prior arrangement. All the menus are based on seasonal availability and are subject to change. Benares serves Halal chicken and Lamb.

Group Menus are available to parties of 9 up to 300 guests. Prices & Menus are subject to change. All dishes presented on each menu will be served to all guests. All dishes from the Tasting menu are served pre plated. Please allow ample time to enjoy this luxurious 7 course menu; service time varies accordingly to the size of the group. No individual choice required. Starters' selection & Desserts will be pre platted individually. Mains will be served "Family style".

We recommend that wine is chosen beforehand with the expert guidance of our sommelier team to compliment your choice of menu. Wine can be chosen on the evening of your reservation, although we cannot guarantee that your choice will be available. The wine list is subject to price changes throughout the year.

Please be aware that occasionally certain dishes and wines become unavailable at short notice due to difficulties with supply. In the event that the quality of produce delivered to us does not meet the approval of our Head Chef, we will endeavor to provide you with a suitable alternative.

Confirmation and Payment

Credit card details will be required to guarantee your booking. In case of no show or cancelation, fees will be charged onto card provided.

Unless otherwise agreed in writing by Benares, payment for an event must be made in full at the end of the event. Value added tax at the current rate is included in all prices and a 15% service charge will be added to your bill.

For EXCLUSIVE HIRE of the entire restaurant, we require a deposit of 50% of minimum spend. Cancellation must be made in advance in writing. The deposit will be returned to you in full provided the cancellation is made no less than 30 days prior to the day of your event. Thereafter, the deposit is non-refundable.
