The restaurant:

The restaurant is available for exclusive hire between 5:30 p.m. to 1:00 a.m., with last drinks at 11:30 p.m.

Exclusive use of the restaurant includes use of the bar area located in the restaurant and does not include The Blind Pig bar.

The menu:

Our menus change according to the best seasonal produce available. A set menu will be devised for your party through discussion with the chef and should be confirmed 2 weeks in advance of the event. In the event certain dishes may become available at short notice due to the fresh nature of the produce, our chefs will endeavour to provide you with a suitable alternative.

The food cost for exclusive hire is fixed regardless of party size which is 60% of the required minimum spend. This is inclusive of canapes, three courses, petit fours and coffee. Any additional courses including cheese, will be charged in addition.

The wines:

At Social Eating House, we take pride in our extensive wine list. Our experienced sommeliers will always be on hand to help you select the appropriate wines for your occasion. We require advance notice of 2 weeks to pre-order wine for your event in order to ensure availability and quantities, or to otherwise suggest alternatives. Please note vintages are subject to change at short notice.

Confirmation:

As agreed, a 50% deposit must be settled through BACS.

The remaining 50% of the minimum spend is payable 1 week prior to the event and must be transferred via BACS. Any amount on top of the required minimum spend will be billed to the client after the event and must be settled via BACS upon receipt of the invoice.

Cancellation:

Cancellation more than 12 weeks or 3 months prior to the event will not be charged and any deposits made will be reimbursed. The 50% deposit will not be reimbursed should the event be cancelled after the 12 week or 3 month required time. If the event is cancelled less than 1 week prior to the date of the booking, the full amount will no longer be reimbursed.
