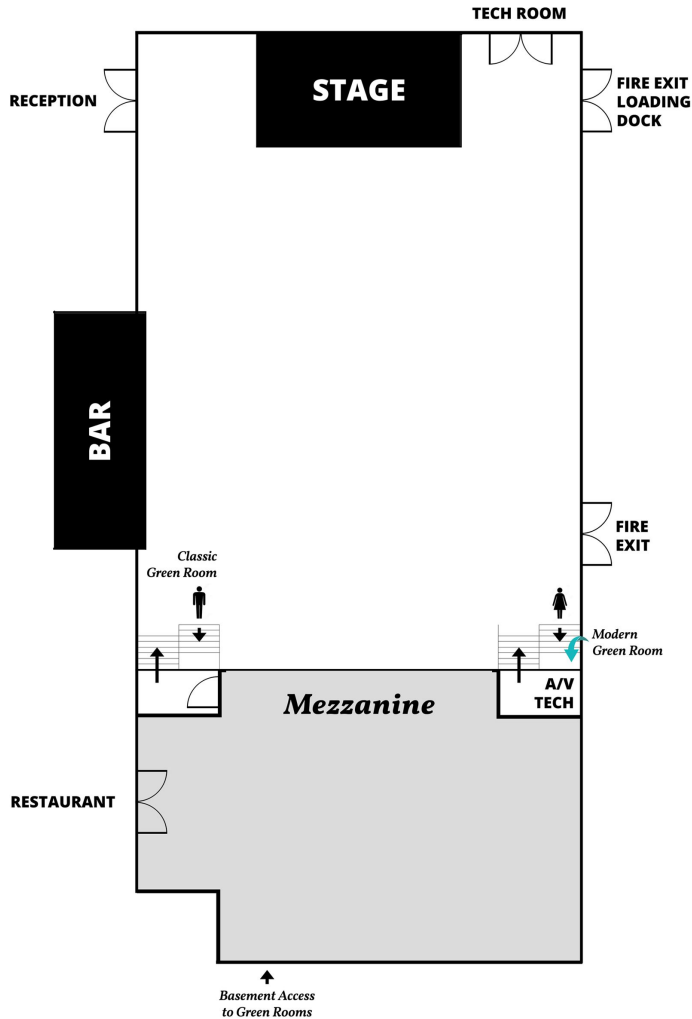

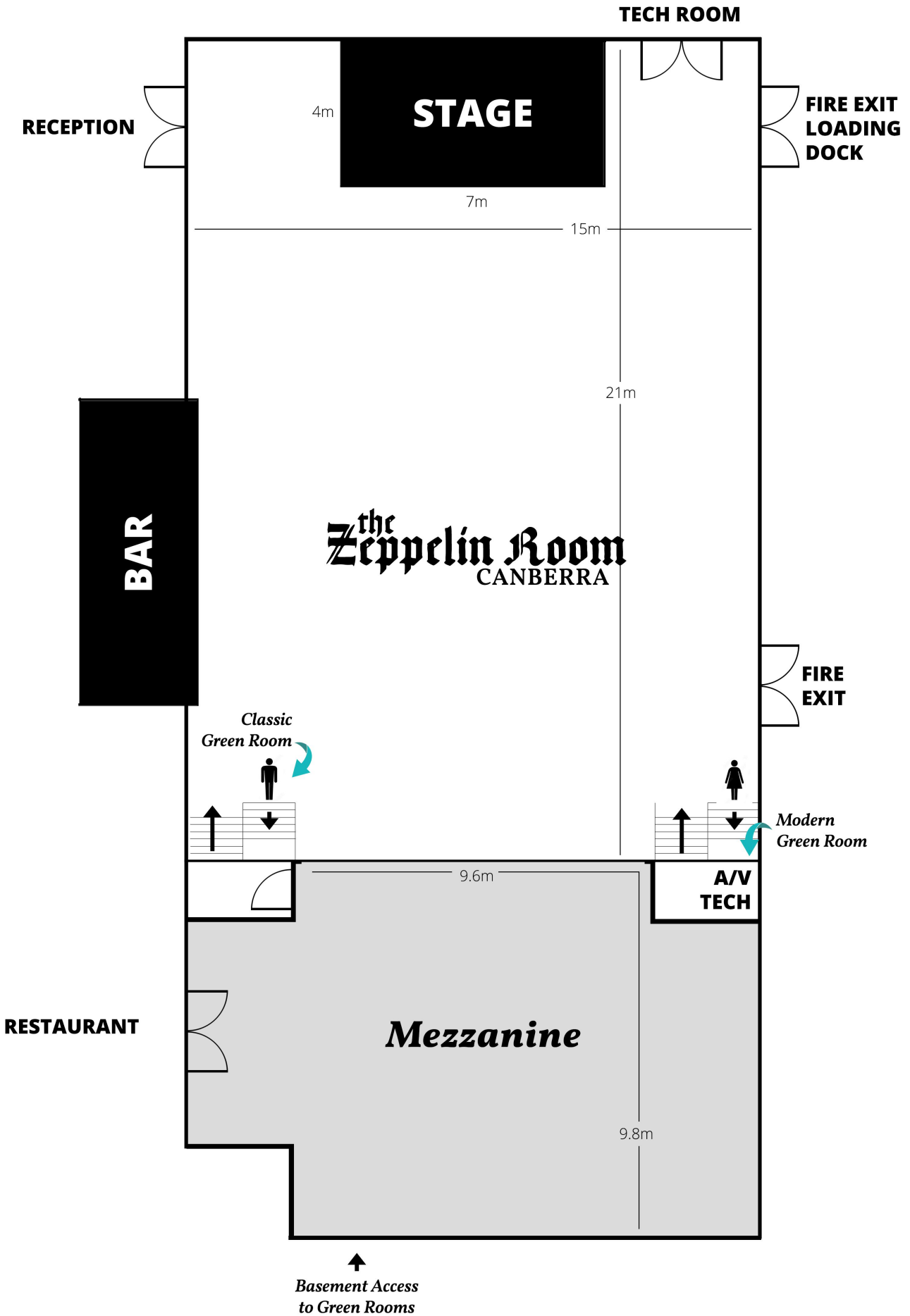

## **Terms & Conditions**

### **RADIUS CLAUSE** (for interstate / international artists)

*25km from Canberra 30 days before and after the event date.*

### **CANCELLATIONS**

*The venue reserves the right to cancel or postpone any event due to poor ticket sales. Cancellation within thirty (30) days of the event will result in loss of deposit. Written confirmation of cancellation is required.*

### **PRICE INCREASES**

*Once a booking arrangement has been reached, the deal will be honoured for a 12-month period, after which time the Harmonie German Club reserves the right to alter the price in line with the club's regular annual price increases.*

### **TRADING HOURS**

*The Harmonie German Club has a midnight Liquor License. All bar trading will cease at 23:30 and patrons will need to have vacated the premises by midnight.*

### **DAMAGE & LOSS**

*Artist is liable for any damages, losses and above normal cleaning costs which may occur as a result of the event. The cost of such damages / losses will be added to the invoice. The Harmonie German Club holds no responsibility for items brought to the event by artists or other patrons.*

### **ALCOHOL SERVICE STANDARDS**

*The Harmonie German Club practices the responsible service of alcohol. Management reserves the right to refuse service of alcohol to intoxicated patrons.*

### **COMMENCEMENT AND VACATING ROOMS**
