



Terms & Conditions

1. DEPOSITS AND PREPAYMENTS

A deposit is required to secure a booking and this amount goes toward any food and beverage spend excluding Nook. The venue reserves the right to request larger deposits during peak months of November and December or for exclusive use events.

2. MINIMUM SPENDS

Nook and The Deck have a minimum spend of \$2500. The minimum spends are a combined group spend during your event and do not need to be paid at the time of booking. Bookings during peak months of November and December higher minimum spends may apply.

3. FINAL NUMBERS

Must be confirmed (7) days prior to the function date. The venue reserves the right to adjust the size of your area on the day of your function if sufficient guests are not in attendance.

4. MENU SELECTIONS

Must be confirmed (7) days prior to the function and may not be changed outside of this period or charges may apply. Allergens are indicated on all food items in our functions menus, please ensure all dietary requirements are communicated to the venue 7 days prior. Please note we cannot guarantee all of our products are 100% allergen free.

5. PAYMENTS

Payment must be received in full prior to your event unless authorisation has been provided for payment at the beginning of your function. Any additional charges must be settled at the conclusion of the function. A 2% surcharge applies to American Express Credit Cards. Direct Deposits can be made to CBA

6. CANCELLATIONS

Cancellations greater than 30 days will receive 50% of their deposit, less than 30 days no refunds will be provided. Functions in the months of November and December or Exclusive Use Events cancelled less than 30 days will be charged at 50% of the minimum spend agreed on.

7. AREA ALLOCATION

The venue reserves the right to substitute a similar space at the management's discretion, however, every effort will be made to fill requests.

8. OTHER FUNCTIONS

All function areas at Niche Bar are reserved spaces and are not private function rooms, apart from Nook and The Deck. Other functions and general public will be located on the same level as your function and as such speeches and music choices are not permitted unless you have reserved the Nook.

9. DECORATIONS AND AV EQUIPMENT

Audio and visual equipment is available and additional costs are raved. Niche does not accept responsibility for any damage or loss of internal/external hire equipment. No decorations are to be nailed, screwed, stapled or adhered to any wall, door, floor or other surface without approval from management. Weighted balloons and small table decorations are permitted, whilst glitter or confetti is not allowed.

10. DRESS CODE

All guests must abide by the venue's dress code. Niche Bar is intended for a mature clientele. At our discretion, we advise the management and staff to enforce dress standards, reserving the right to refuse entry on a one-by-one basis as per the liquor control act. Smart attire Fridays and Saturdays. Tattoos to be discreetly covered. No dirty or torn clothing. Please access our website for full detailed dress code standard.

11. MINORS AND LIQUOR ACT

Under Western Australian Law, all guests under the age of 18 must be accompanied by their legal guardian and supervised at all times. All guests under the age of 18 must vacate the venue by 8pm. All guests must be over the age of 18 to consume alcohol and provide identification when requested.

12. RESPONSIBLE SERVICE OF ALCOHOL Niche bar abides by WA Guidelines on responsible service of alcohol as per our house policy. The venue reserves the right to refuse service of alcohol to any patron deemed to be showing signs of intoxication, this includes all guests as part of a function or on a beverage package.

13. SPECIAL REQUIREMENTS

It is the responsibility of the host to inform all guests that entry will be refused if the following conditions are not met: dress code standards and Valid ID. which consists of; CURRENT Australian Driver's Licence with photograph or CURRENT Passport or CURRENT Proof-of-Age card. Irrespective of age all patrons must present ID upon request and for scanning via Scantek.
