



GROUP RESERVATION REQUEST FORM

We consider any party of 8 guests or more a 'group reservation'. We have procedures in place to ensure smooth service of groups. By proceeding with your reservation request, you are agreeing to the Terms & Conditions outlined below. Please read carefully.

- 1. Reservations between 12pm 2:30pm & 5pm 6:30pm are for 2 hours maximum commencing from the reservation time (exceptions may be available subject to minimum spends). Please kindly advise all guests in your group so that your sitting is not rushed; our Chef's Menu comfortably requires 2 hours.
- 2. All parties of 8+ are required to dine from our $\$79\mathrm{pp}$ Tasting Menu.
- 3. A 15% service charge applies to all groups of 6 or more.
- 4. Non-private group reservations of 17 or more guests are only confirmed once a deposit of \$50pp is secured.
- 5. Groups requiring private use of a dining area, a deposit to the value of \$85pp is required to secure the reservation. All secured deposits will be redeemed against your final bill on the day.
- 6. We will do our utmost to seat your group in your preferred dining area, however, we are not able to guarantee this, unless you have reserved a private dining area. Minimum spends apply to secure private areas. Minimum spends are not inclusive of the 15% service charge applied to your final bill.
- 7. Simple table decorations are permitted, however, we request that guests refrain from using confetti/ glittery decorations, or anything that would require adhering onto the building's walls or structure.
- 8. We are a fully licensed venue, and do not accept BYO. Drinks packages cannot be mixed and matched within a group. We can offer a separate bar tab, however, cannot offer pay-as-you go drinks. Drinks packages and prearranging beverage options are advised for large groups and private functions to ensure we have the products on hand. We require confirmation at least one week in advance of your reservation.
- 9. Full payment of the event will be taken at the end of your session. We are able to split bills however your guests will need to calculate their share inclusive of service charge if required.
- 10. If you need to cancel a reservation, deposits are refundable only if a written request is received and approved with a minimum of 72 hours' notice for non-private bookings of 17 or more guests, and a minimum of 5 days' notice for Private Dining Room bookings. Cancellations made with less than the required notice will result in the forfeit of the deposit to cover costs, including those related to pre-ordering. Please contact the restaurant for assistance if needed.
- 11. Your reservation is not confirmed in our diary until we have received your completed Group Reservation Request Form, along with valid credit card details (and processed deposit if required). Please note that the diary remains live for other guests to reserve online, so your preferred date & time is not guaranteed. You will receive email confirmation once your reservation has been confirmed in the diary.
