# **General Information**

This qualification guide contains details of everything you need to know about the OCNLR Level 1 Award and Certificate in Creative and Digital Media. It indicates the curriculum areas covered, identifies the learners for whom the qualifications have been developed and specifies the rules of combination for achievement. The guide also covers important aspects of assessment and moderation that are particular to the qualifications. The guide should be used by all involved in the delivery and assessment of the qualifications.

# **Qualification Overview**

The OCNLR Level 1 Award and Certificate in Creative and Digital Media qualifications have been developed to provide a flexible introduction to this exciting and important vocational sector. In the UK, the creative industries employ nearly three million people and add £80 billion to the economy every year. Helping develop interest in this sector and unleashing the latent talent of future creative and digital media workers, is hugely important for the UK and provides real and extensive opportunities for learners in richly varied fields and roles. These qualifications provide a means for that all-important introduction to the subject, which, it could be argued, provides a set of subjects with unparalleled potential for engaging even disaffected and challenged learners, as well as others, through practical project based and creative work right from the start of their studies.

While these qualifications are at level 1, entry three level versions are also in development and should be available within a month of the level 1 qualifications, allowing development and progression from a very accessible starting point. The qualifications have been designed to include options both covering subject specific skills, and options for learning and employment skills development, preparing learners for further progression in the subject, and generally.

The OCNLR Level 1 Award and Certificate in Creative and Digital Media qualifications are regulated by Ofqual, the qualifications regulator for England, and are registered on the Regulated Qualifications Framework (RQF).

# Purpose of the qualifications

The OCNLR Level 1 Award and Certificate in Creative and Digital Media qualifications have been designed to provide learners with the underpinning skills and knowledge required to progress to further study relating to creative and digital media and ultimately to work in this or other related sectors.

# Who the qualifications are for

The qualifications are for learners of all ages who wish to progress in creative and digital media related vocations. They offer an opportunity to develop essential study skills along with vocational units to create a firm foundation for successful progression to Level 2 qualifications. The Award is ideal for learners who are not yet ready to commit to a larger qualification.

### Learners may be:

- 14-19 years old in full-time study;
- adults who wish to progress to higher level qualifications for example in creative and digital media or computing and digital technologies;
- currently employed in a role related to creative and digital media and wish to
- currently not in employment and looking to improve their future career prospects.

# **Entry guidance**

There are no specific entry requirements for these qualifications, however, providers must assess the suitability of units for younger learners before delivery.

# Progression and related qualifications

On completion of one of the OCNLR Level 1 Award and Certificate in Creative and Digital Media qualifications learners will have the required skills and knowledge to progress to qualifications at a higher level in related subjects. These qualifications represent the first step in a clear progression route through to vocational learning or higher education. Alternatively, learners may progress to employment in entry level roles in creative and digital media settings.

# **Structure of the Qualifications**

#### Rules of combination for achievement

The rules of combination are designed to ensure an appropriate proportion of *subject* related learning is evidenced for learners to be awarded either of these qualifications.

Optional Group 1 consists of specific subject related units.

Optional Group 2 consists of general development, learning and employment skills related units.

The OCNLR Level 1 Award in Creative and Digital Media qualification has no mandatory unit and several optional vocational units to choose from, structured into two groups.

Learners must achieve 6 credits in total:

- 3 credits from Optional Group 1. Optional Group 1 consists of optional units all relating to creative and digital medial related subjects;
- 3 other credits from Optional Group 1 or Optional Group 2. Group 2 consists of more general study or general employment related subjects.

The OCNLR Level 1 Certificate in Creative and Digital Media qualification has no mandatory units and several optional vocational units to choose from, structured into two groups.

Learners must achieve 15 credits in total:

- 9 credits must from Optional Group 1;
- Any of the remaining 6 credits may be taken from either Optional Group 1 or Optional Group 2.

# **Assessment and Moderation**

#### Assessment process

The assessment process for these qualifications is as follows:

- the learners are assessed through activities that are internally set by tutor/assessors:
- the activities must be designed to enable learners to meet the assessment criteria of the unit:
- learners' portfolios of assessed evidence must be internally moderated at the Centre;
- the portfolios of assessed evidence will be externally moderated by an OCN London External Moderator.

There is no additional external assessment for these qualifications.

## **Devising assessments**

Each unit has a supplementary page with suggestions for the types of assessment activities that can be used to assess learners against the unit. Tutor/assessors should refer to this page before devising assessment tasks.

OCN London assessment guidance relevant to the units in the qualifications is in the OCNLR Assessment Guidance and Ofgual Level Descriptors section of this qualification guide. The guidance includes a general description of the activity and the type of evidence that is appropriate. The activity or activities set must enable the learners to meet the standards detailed in the assessment criteria. Please contact OCN London for further guidance on devising appropriate assessments.

Centre-devised assessments should be scrutinised by the Internal Moderator before use to ensure that they are fit for purpose. Centre-devised assessments will be scrutinised by the External Moderator to ensure reliability and validity of assessment.

# Marking assessment activities

Each activity must be marked against the identified assessment criteria in the unit and judged to be either achieved or not achieved.

Tutor/assessors need to ensure that the work in a learner's portfolio is:

- authentic it is the result of the learner's own performance or activity;
- sufficient enabling the tutor/assessor to make a consistent and reliable judgement;
- adequate appropriate to the level.

Where a series of activities are set, learners must demonstrate the achievement of the required standard identified in the assessment criteria in all activities. All the assessment criteria in a unit must be met before the unit is deemed achieved.

The unit achievement is not graded. Units are either achieved or not achieved.

#### **Standardisation**

Standardisation is a process that promotes consistency in the understanding and application of standards in relation to assessment. It:

- compares assessment judgements from different tutor/assessors
- promotes consistent judgements by different tutor/assessors;
- identifies good practice in assessment;
- promotes the sharing of good practice in assessment between Centre staff.

Standardisation events should be held periodically within Centres to ensure consistent and effective assessment practice. Standardisation events may also be held by OCN London and it is a requirement that each Centre offering units from the qualification must contribute assessment materials and learners' evidence for standardisation, if requested.

OCN London will notify Centres of the required sample for standardisation purposes and assessment materials, learners' evidence and tutor/assessor feedback may be collected by External Moderators.

# Learners with particular requirements

If learners have particular requirements the Centre should refer to the Access to Fair Assessment Policy and Procedure which gives clear guidance on the reasonable adjustments and arrangements that can be made to take account of disability or learning difficulty, without compromising the achievement of the assessment criteria.

# Requirements for tutor/assessors

### To be sufficiently competent

In addition to being qualified to make assessment decisions, each tutor/assessor must be capable of carrying out the full requirements within the competency of the units they are assessing. This competence should be maintained annually through clearly demonstrable continuing learning and professional development.

Expert witnesses can be used where they have suitable expertise for specialist areas. The use of expert witnesses should be determined and agreed by the tutor/assessor.

#### To be sufficiently knowledgeable

Each tutor/assessor should possess relevant knowledge and understanding of the subject and so be able to make robust and reliable assessment decisions in relation to the subject.
