## **Qualification Overview**

The OCNLR Level 3 Certificate in Mediation Theory and Practice qualification has been developed in consultation with experienced practitioners and employers to offer an advanced level qualification for practitioners already working in the sector, for those who want to train to be mediators and for learners who have already achieved the Level 2 and 3 Awards in Understanding Mediation and wish to develop more advanced skills.

This qualification is made up of three mandatory units covering the generic mediation skills of 'Conflict Theory and Mediation', 'Facilitating Mediation' and 'Using People Skills in the Mediation Process'.

In addition, at least one optional unit must be studied from the Group A skills areas of 'Workplace Mediation', 'Community Mediation', 'Family Mediation', 'Civil Mediation' and 'Mediating in Customer and Consumer Complaints'; and a second optional unit must also be taken either from the Group A skills units or from the method units of 'Evaluative Mediation', 'Narrative Mediation', 'Transformative Mediation', 'Nonviolent Communication and Concepts' and 'Facilitative Model' of Mediation in Group B.

Learners will acquire skills and knowledge in the following areas:

- building alliances;
- effective negotiation;
- planning and delivering a campaign;
- evaluating own actions.

The OCNLR Level 3 Certificate in Mediation Theory and Practice qualification is regulated by Ofqual, the qualifications regulator for England, and are registered on the Regulated Qualifications Framework (RQF). It is not a licence to practise.

#### Purpose of the qualification

The purpose of the OCNLR Level 3 Certificate in Mediation Theory and Practice qualification is to provide the learner with either a progression route from the Level 2 and Level 3 Awards in Understanding Mediation or to offer them opportunities to deepen their understanding and develop more advanced and specialised skills in mediation theory and practice.

#### Who the qualification is for

- The **OCNLR Level 3 Certificate in Mediation Theory and Practice** qualification is suitable for Mediation practitioners, volunteers and students who:
- would like to have their existing mediation skills recognised through the achievement of a nationally recognised qualification;
- would like to acquire more advanced knowledge of theory and practice in a variety of mediation skill areas;
- wish to acquire the necessary underpinning knowledge that will enable them to move forward with their continuing professional development;
- wish to enhance their employment opportunities and prospects.

Employers in a range of organisations:

- as a useful tool to provide human resource and other staff with advanced skills in the field of conflict resolution and for the continuous professional development of their workforce;
- to provide staff with a recognised qualification on the national framework.

The qualification can be offered to a range of learners such as mediation practitioners, volunteers, human resource staff or students on related courses.

#### Entry guidance

This qualification is suitable for learners aged 19+. The minimum age for access to the qualification is 19 years.

#### **Additional information**

The OCNLR Level 3 Certificate in Mediation Theory and Practice does not confer Occupational Competence but supports individuals in their current job role or future job roles.

#### Progression and related qualifications

This qualification provides continuing professional development for candidates to gain skills that will enable them to move into new areas of mediation practice and to improve their employment prospects. Where the qualification is taken as 'in service' training it could enhance progression opportunities within the place of work.



## Structure of the qualification

#### Rules of combination for achievement

The OCNLR Level 3 Certificate in Mediation Theory and Practice qualification comprises mandatory and optional units. Learners must achieve 15 credits in total.

- 8 credits must be taken from the mandatory units
- 7 credits from optional units
  - at least 4 credits must be taken from optional group A. Remaining 3 credits can be taken from either optional group A or B.

### Assessment and Moderation

#### Assessment process

The assessment process for this qualification is as follows:

- The learners are assessed through activities that are internally set by tutor assessors;
- The activities must be designed to enable learners to meet the assessment criteria of the unit;
- Learners' portfolios of assessed evidence must be internally moderated at the Centre;
- The portfolios of assessed evidence will be externally moderated by an OCN London External Moderator.

There is no additional external assessment for this qualification.

#### **Devising assessments**

Each unit has a supplementary page with information on the types of assessment activities that can (indicated as 'Optional' or 'O') and/or must (indicated as 'Prescribed' or 'P') be used to assess learners against the unit. Tutor assessors must always refer to this page before devising assessment tasks.

OCN London assessment guidance relevant to the units in this qualification is in the 'OCNLR <u>Assessment Guidance and Ofqual Level Descriptors'</u> section of this qualification guide. The guidance includes a general description of the activity and the type of evidence that is appropriate. The activity or activities set must enable the learners to meet the standards detailed in the assessment criteria. Please contact OCN London for further guidance on devising appropriate assessments.

Centre devised assessments should be scrutinised by the Internal Moderator before use to ensure that they are fit for purpose. Centre devised assessments will be scrutinised by the External Moderator to ensure reliability and validity of assessment.

#### Marking assessment activities

Each activity must be marked against the identified assessment criteria in the unit and judged to be either achieved or not achieved.

Assessors need to ensure that the work in a learner's portfolio is:

- Authentic it is the result of the learner's own performance or activity;
- Sufficient enabling the assessor to make a consistent and reliable judgement;
- Adequate appropriate to the level.



Where a series of activities are set, learners must demonstrate the achievement of the required standard identified in the assessment criteria in all activities. All of the assessment criteria in a unit must be met before the unit is deemed achieved.

The unit achievement is not graded. Units are either achieved or not achieved.

#### Standardisation

Standardisation is a process that promotes consistency in the understanding and application of standards in relation to assessment. It:

- compares assessment judgements from different tutor/assessors;
- promotes consistent judgements by different tutor/assessors;
- identifies good practice in assessment;
- promotes the sharing of good practice in assessment between centre staff.

Standardisation events should be held periodically within centres to ensure consistent and effective assessment practice. Standardisation events may also be held by OCN London and it is a requirement that each Centre offering units from this qualification must contribute assessment materials and learners' evidence for standardisation, if requested.

OCN London will notify Centres of the required sample for standardisation purposes and assessment materials, learners' evidence and tutor feedback may be collected by External Moderators.

#### Learners with particular requirements

If learners have particular requirements the Centre should refer to the 'Access to Fair Assessment Policy and Procedure' which can be found on our website at: <u>Access to Fair</u> <u>Assessment Policy and Procedure</u> and gives clear guidance on the reasonable adjustments and arrangements that can be made to take account of disability or learning difficulty, without compromising the achievement of the assessment criteria.

#### Requirements for tutor/assessors

#### To be sufficiently competent

In addition to being qualified to make assessment decisions, each assessor must be capable of carrying out the full requirements within the competency of the units they are assessing. This competence should be maintained annually through clearly demonstrable continuing learning and professional development.

Expert witnesses can be used where they have suitable expertise for specialist areas. The use of expert witnesses should be determined and agreed by the assessor.



#### To be sufficiently knowledgeable

Each assessor should possess relevant knowledge and understanding of the subject and so be able to make robust and reliable assessment decisions in relation to the subject.
