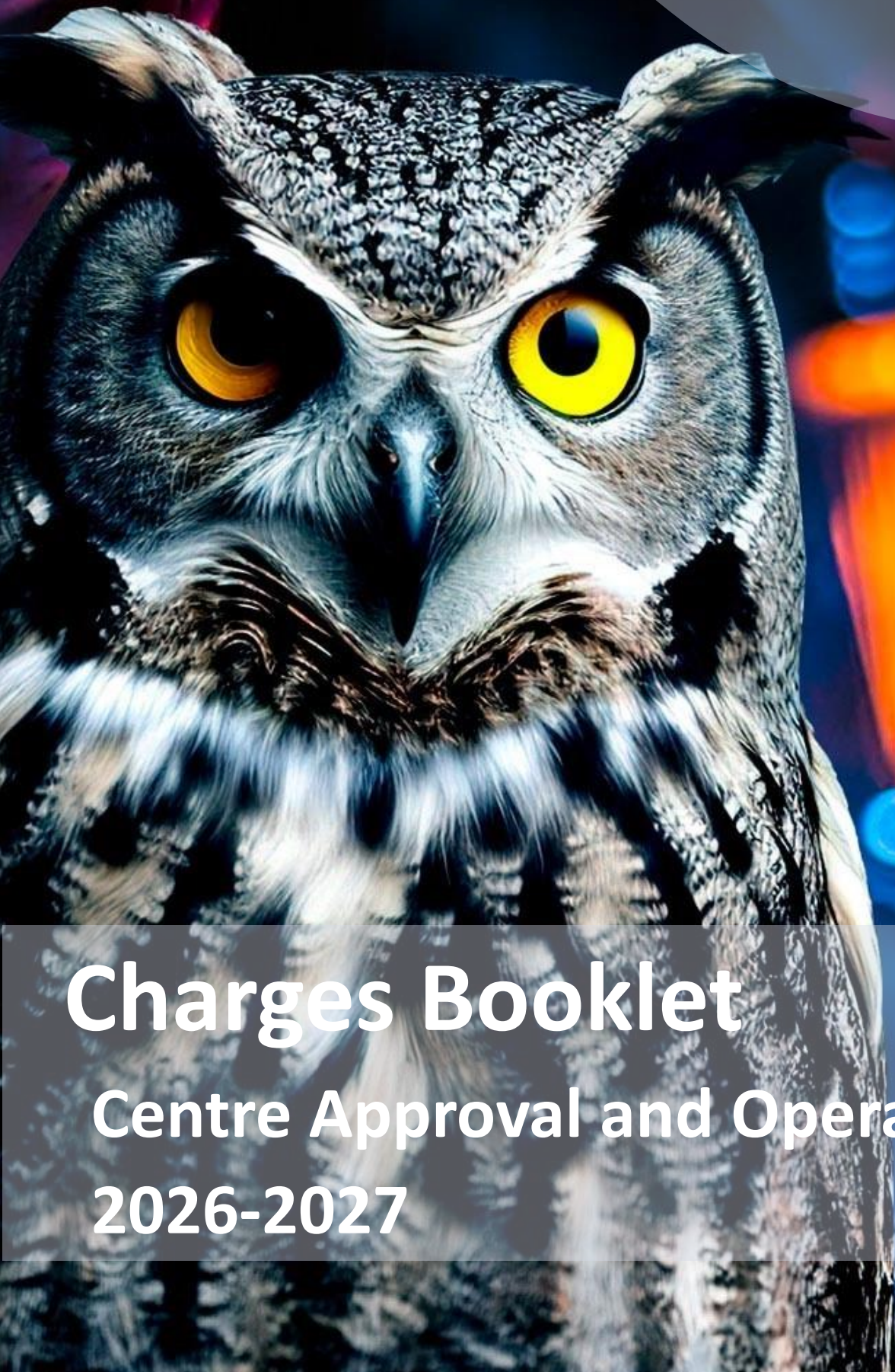

Centre Approval

OCN London offers a single gateway approach to approving all of the organisations that we work with. This means a single set of criteria and application fees for all centres and access to our core offer.

The centre approval process involves an application and an OCN London evaluation. We support new centres through the approval process, provide guidance, offer advice on regulated and bespoke qualifications and may visit your centre to confirm the application. The centre approval evaluation fee only applies to centres who don't already work with OCN London.

All OCN London approved centres are provided with access to a comprehensive package of services and support, including:

- Able to apply to deliver any qualification from our extensive range or to develop tailored accreditation of your courses to meet your specific requirements.

OCN London Endorsed

OCN London Endorsed is designed for organisations and employers who are seeking a quality badge for the in-house training they develop and deliver. Different from our other services, OCN London Endorsed **does not involve the assessment** of learners and the requirement to provide evidence of achievement from them.

OCN London Endorsed gives approved centres the recognition from OCN London for the quality of the courses created. It also provides a means for helping to assess the effectiveness of delivery against each course’s aims and purpose.

Annual Centre Approval Fee

The centre approval fee covers the period from 1 August 2025 to 31 July 2026.

For centres offering OCN London regulated and or/bespoke qualifications, there is an annual centre approval fee based on the volume of learners registered in the previous academic year.

For centres only accessing our core offer, the annual centre approval fee is £990, which includes an annual refresh of your initial evaluation.

For College Groups, the annual centre fee will be determined on a case-by-case basis.

Learner Registration and Certification Fee

When you register learners there is a combined charge for learner registration and certification on all of our regulated, bespoke qualifications and microcredentials. This fee is charged at the point of registration and is non-refundable.

OCN London regulated qualifications

The qualification fee will be charged at the point of registration. Any credits achieved over and above the qualification will be charged at the credit band rates (see table below); this charge will be incurred at the point of certification.

OCN London bespoke qualifications

Bespoke qualifications are charged according to the total credit value for the course. We charge a fee per learner, invoiced at the point of registration.

Late Registration Fee

If you do not register the learners within the deadlines explained below you will incur a late registration fee of **£23 per learner**.

Learner registration deadlines

Short courses (15 weeks or less)

Learners must be registered with OCN London within 25 working days of the start of the course.

Long courses (16 weeks or more)

Learners must be registered with OCN London within 60 working days of the start of the course.

Certificates and E-Certificates

The learner registration fee also covers the cost of certification. Completing learners, registered onto OCN London regulated or bespoke qualifications, will receive a paper certificate (unless the centre has opted out from receiving these) and a verifiable e-certificate.

Centres offering OCN London Endorsed courses can request a paper record of attendance or completion at a cost of **£13 per learner**, or a digital badge (see pricing below).

Digital Badges

Every approved OCN London centre will receive **50 free participation badges** as part of our core offer.

Digital badges can be used in a variety of ways:

- Celebrating high levels of attendance;
- Recognising volunteering work;
- Attending work placements and events.

Where more than 50 badges are issued, centres have the choice of paying for additional badges on a pay-as-you-go basis, where each additional badge will be charged at **£7 per badge** (volume discounts apply).

Alternatively, blocks of badges can be purchased, at a preferential discounted price, as shown in the table below.

Microcredentials

OCN London produces microcredentials in current and in-demand skills, accessible to centres upon approval (see website or qualification charges booklet for further information). In addition, centres are able to have their own stand-alone or pathway of microcredentials formally recognised and awarded.

OCN London works with centres to develop bespoke qualifications that precisely meet the needs of their learners and context. Whether you are looking to accredit existing in-house provision or build something entirely new, our curriculum development experts will support you through the process. The following fees apply.

Bespoke Qualification Review

All OCN London bespoke qualifications are subject to a three-year review. This ensures that qualifications remain current, effective and responsive to learner feedback, and reflect any shifts in policy, legislation or sector practice relevant to the qualification's subject area. Centres are expected to demonstrate best practice throughout the life of their qualification – not only at the point of review. This means maintaining ongoing responsiveness to learner outcomes and any developments in the relevant field.

The Review Process

The review is undertaken collaboratively by OCN London and the centre. It will involve a meeting to discuss the qualification's performance since approval, any amendments the centre has already made, and any further changes they wish to make going forward.

Where a centre wishes to make significant changes to the content or structure of a qualification, OCN London will advise whether these constitute a new version of the qualification – which may attract a new development fee – or fall within the scope of the review.

A review fee applies, scaled according to the size of the qualification, as shown below. For qualifications at higher levels where a subject matter expert (SME) is required, an additional SME fee will apply.

Initial consultancy for preparing and submitting an application to the OCN London Approvals Board is included as part of our core offer.

External Quality Assurance and Support

An External Quality Assurance (EQA) schedule for the year will be set by the OCN London centre EQA to reflect the nature and volume of provision.

For most active centres, this is likely to include the equivalent of between one and two days' engagement per year, which may be through visit(s), remote sampling or a combination of these. Where a centre has a particularly high volume of learners, additional time can be agreed at no additional charge to reflect the delivery schedule.

If the centre requests EQA over and above the agreed schedule, or if additional EQA is required for quality reasons, the charges below will be applied. Charges will also be applied for cancelled EQA engagements where insufficient notice has been given or where EQA cannot proceed on the day due to insufficient preparation at the centre - including learners not having been registered and/or results not entered.

Training

OCN London's training provision for practitioners is available to anyone who wishes to take advantage of it, but the charges are reduced for our approved centres. The following courses take place regularly and are normally offered online to increase accessibility.

Refund

International Centres

Where applicable, any international travel and subsistence expenses incurred by OCN London in connection with centre approval, quality assurance activities, monitoring visits, training, consultancy, or other services requested by the centre shall be charged to the centre. In addition, the applicable OCN London staff daily rate will be charged for the time spent delivering such services. All such costs will be agreed with the centre in advance wherever reasonably practicable.

Charges for other services

Charges for other services agreed with OCN London will be levied at the discretion of the Chief Executive Officer.
