

# ITMA's Mission, Objectives and Strategy



### The Irish Traditional Music Archive

ITMA was established as part of an Arts Council / An Chomhairle Ealaíon policy initiative in 1987. A pilot project proposed by Nicholas Carolan and Harry Bradshaw was funded and supported, and has grown into what we now know as ITMA. The impetus of the policy initiative was to support the development of Irish traditional music by focusing on the centrality of the process of transmission in the living tradition. We collect, preserve, organise and make available the materials of Irish traditional music in both the Irish and English languages. Our role is to be an agent of transmission, closely linked to contemporary practice, and in constant interaction with artists and audiences.

### ITMA's Vision

Our vision is of ITMA as a progressive, established, national archive and resource centre for Irish traditional music, playing a key role in the development of a vibrant traditional arts and heritage sector that is positioned at the heart of Ireland's cultural, social and economic life.

### ITMA's Mission

ITMA's mission is to be the national public archive and resource centre for Irish traditional music, song and dance, and the globally recognised specialist advisory agency to advance appreciation, knowledge, and the practice of Irish traditional music.

We will do this by continuing to:

- collect and preserve the historical and contemporary materials of Irish traditional music, particularly those that are at risk
- organise and describe these materials according to international standards of archival and library practice to create collections that are discoverable by all
- present and publish content from our collections in ways that enhance the living tradition; contribute to the knowledge base of traditional music, and engage with our diverse audiences worldwide

### ITMA's Values

- Respect for all music, song and dance collections in our care and for those who create and donate the materials
- Commitment to free and open access to collections while respecting privacy and legal obligations
- Act with dignity, fairness and kindness in all engagement with users
- Embrace diversity and inclusiveness



The Irish Traditional Music Archive (ITMA) celebrated a remarkable year of progress and resilience in 2024. Despite the challenges of a competitive funding environment, ITMA continued its mission to preserve, digitise, and share Ireland's music, song, and dance heritage, ensuring its archives become increasingly accessible to anyone, anywhere, at any time. Some of our achievements in 2024 include:

### **Digitisation Milestones**

Thousands of archival materials, including over 10,000 78 RPM records, were organised and inventoried in 2024. With funding from the Government of Ireland's Shared Island Initiative and specialised equipment from the Heritage Council, ITMA

now benefits from excellent in-house audio and audio-visual digitisation capabilities, enhancing autonomy and quality control.

### **Digital Storage Expansion**

ITMA nearly doubled its internal storage capacity from 200TB to close to 400TB in 2024, creating scalable infrastructure for a growing digital archive.

### **Rights and Permissions**

Clearance efforts advanced significantly to pave the way for landmark collections like the Breandán Breathnach Archive to become more widely accessible.

Along with this expansion of digital infrastructure, ITMA continued to inspire contemporary creativity and collaboration in 2024 through our artistic programming.

The *Drawing from the Well* concert series, in partnership with the National Concert Hall, continued with two more well-attended performances in 2024. On 14 March, *Drawing from the Well: Tommie Potts* celebrated the artistry of Dublin fiddler Tommie Potts, featuring Noel Hill, Sibéal Davitt, poet Paula Meehan and Sharon Carty, among others, and hosted by Dónal Fallon. On 6th October, artists such as Louise, Mick and Michelle Mulcahy, Zoë Conway, and Seán McKeon brought archival-inspired creativity to the National Concert Hall in front of a sold-out audience.

September 2024 saw the return of the annual *Drawing from the Well Concert Tour*, which saw six performances in six different venues across Ireland. The lineup for this year's tour featured Derek Hickey, Aoife Ní Bhriain, Stephanie Keane, and Iarla Ó Lionáird, along with outstanding local artists each night. It is very rewarding to see our tour bringing the archive's services into local, regional and rural venues as we seek to deepen our impact locally, nationally and internationally.

Our artistic programming in 2024 was not only available to those in-person, but also served our digital audience around the world. The year saw the continuation of our monthly *Saothar* web series, which showcases compositions by contemporary traditional artists. This year's *Saothar* composers included Michael Flatley, Martin Hayes, Sorcha Costello and Brenda Castles, whose compositions ranged from tributes to Princess Grace of Monaco to pieces inspired by bumblebees and the ecological concerns they face.

Beyond Saothar, other notable online projects this year include Anton Zille's work on Dennis Murphy recordings from the Breandán Breathnach Collection at ITMA. Anton prepared an online collection for ITMA.ie that featured hours' worth of recordings of Sliabh Luachra fiddle master Dennis Murphy along with transcriptions, note cards and other associated materials. Anton's work helps to further preserve Denis Murphy's unique style and legacy within Irish traditional fiddle music.

ITMA's production capabilities reached new heights in 2024, with multiple programmes and films broadcast on television and screened in cinemas.

In January 2024, ITMA screened its original production, Seán Keane: A Portrait of an Artist at the Irish Film Institute in Dublin. The documentary celebrates the legacy of the legendary fiddle player and member of The Chieftains.

Just over a month later, ITMA's documentary *Brendan Gleeson's Farewell to Hughes's* made its world premiere at the Dublin International Film Festival. Directed by Ciarán Ó Maonaigh and co-produced by ITMA and actor Brendan Gleeson, the documentary honors the legacy of Hughes's pub in Dublin. After its premiere sold out in less than 24 hours, the film had a threemonth run in the Lighthouse Cinema in Dublin, followed by a broadcast on TG4 in December 2024. The film received great critical acclaim and was nominated in the Best Documentary at the Irish Film and Television Academy Awards.

May 2024 saw the broadcast of *Taoscadh ón Tobar*, an ITMA/TG4 docuseries now freely available on the TG4 Player. The series brought Ireland's traditional music to life as artists Andrea Palandri, Iarla Ó Lionáird, Doireann Ní Ghlacaín, Seán McElwain and Muireann Nic Amhlaoibh uncovered the stories of significant

musicians, singers, collectors, and regions by exploring our archives over the course of five episodes.

It is worth noting that the full interviews and recordings that are made as part of these productions make for excellent archival footage. For every hour of final edited footage that appears on screen, we have tens of hours of bonus footage and in-depth content that will live on in the archive.

Meanwhile, on the radio, continued collaboration with RTÉ Radio 1 and Aoife Nic Chormaic's The Rolling Wave have helped to amplify ITMA's reach. These partnerships, featuring pro-bono contributions from Professor Pádraic Mac Mathúna, highlight the importance of public service broadcasting in showcasing Ireland's cultural heritage.

### **Expanding Dance Archival Collections**

Over the course of 2024, ITMA deepened its commitment to preserve Irish traditional dance through various dance-related projects.

Collaborations with Edwina Guckian and Cailtín Nic Gabhann saw field interviews with practitioners from around the country to document and preserve their traditions. The unique set dancing style of West Kerry was documented as part of a Foras na Gaeilge-funded film project, presented by Clíodhna and Méabh Ní Bheaglaoich.

Collectors and practitioners Helen Brennan, Michael Tubridy, and John Cullinane enriched ITMA's dance archives through interviews and donations of precious Irish dance recordings and materials.

### Those We've Lost

Each year, the Irish traditional arts community mourns the loss of numerous esteemed tradition bearers whose contributions have profoundly enriched our cultural heritage. In 2024, we bid farewell to several such luminaries, including the renowned composer and musician Charlie Lennon.

Charlie Lennon's compositions have become integral to Irish music sessions worldwide, from Bantry to Boston. His dedication to the craft was unwavering, as he continually sought to learn and innovate within the tradition. His passing is a significant loss to the musical community.

In March 2023, Charlie delivered a memorable performance at the National Concert Hall during our Drawing from the Well concert, captivating the audience with his mastery as a fiddle player, pianist, and composer. ITMA was privileged to conduct



an in-depth interview with him, preserving his insights and experiences for future generations.

We also remember with deep respect many other tradition bearers who left us in 2024, such as Séamus Ó Dubháin and Sliabh Luachra's Timmy O'Connor. Fortunately, ITMA had the opportunity to document their unique knowledge and artistry through interviews, ensuring that their legacies endure. However, we are acutely aware of the challenges we face, with a

significant backlog of interviews awaiting publication and many tradition bearers yet to record. Each missed opportunity is a poignant reminder of the fragility of our cultural heritage and the imperative to honour these extraordinary individuals by preserving their stories, music, and dance for future generations.

At ITMA, we remain steadfast in our commitment to capturing and sharing the rich tapestry of Irish traditional arts, ensuring that the voices and talents of our tradition bearers continue to inspire and resonate across time and place.

# Acknowledging Key Funders and Supporters

ITMA wouldn't have been able to achieve this progress over the past 12 months without the support we receive from our funders and partners. ### **Looking Ahead to 2025**

In the year ahead, we hope to build on our momentum from 2024 and continue to provide the public with increased access to the archive and our shared tradition.

We will continue our Drawing from the Well concert collaborations with the National Concert Hall, and expand our international reach with performances in Paris at the Centre Culturel Irlandais (CCI), and Le Philharmonie, while also deepening our roots in local communities.

We plan to develop educational initiatives with new partners, including The Irish American Partnership, to inspire the next generation.

We're looking forward to a Shared Island Flute residency that will celebrate the diverse flute traditions across the island. This next year will see the release of a biography of Tommie Potts, authored by Seán Potts, with contributions from Aoife Nic Chormaic and Aoife Ní Bhriain. ITMA will begin work on the exceptional song collections of Christy Moore, Pádraigín Ní Uallacháin and Len Graham in 2025, preserving their invaluable contributions to the Irish song tradition.

All the while, we will continue our digital expansion, ensuring even more of the archive is accessible to remote users worldwide.

I would like to extend a heartfelt thanks to all of ITMA's dedicated full-time staff, pro-bono contributors, interns, volunteers, artists, and service providers whose incredible hard work, creativity, and collaboration have been the foundation of our success this year.

ITMA's achievements in 2024 were only possible because of the support of our funders, donors, and community.

I would like to thank, acknowledge and show gratitude to all the donors who entrusted ITMA this past year with contributions ranging from €5 to \$100,000. Every single euro and dollar donated has helped to drastically improve ITMA's outlook for the year to come.

As we look ahead, we remain committed to preserving Ireland's music, song and dance heritage and making them accessible to anyone, anywhere, at any time.

# **Fundraising**





In 2024, an anonymous U.S. foundation pledged to make a matching donation if ITMA could raise \$100,000 (€95,000) over the course of the year. Thanks to a swell of support from all around the world, ITMA reached this goal.

In total, ITMA received more than 540 donations over the course of 2024 worth €167,530. Once we process corporate contributions and CHY3 forms from our Irish-based donors in the first quarter of 2025, this number will rise beyond \$200,000. So far, donations from 2024 have helped to increase digitisation and cataloguing capacity to make more archival materials freely available around the world.

ITMA is on a journey to democratise access to traditional music, song and dance by digitising our archival collections, making them accessible to anyone, anywhere, at anytime. We need additional financial support to achieve this goal.

Donations to ITMA can go towards hiring new staff to catalogue, clear rights and permissions and digitise audio and visual materials. They can fund further equipment and digital storage upgrades. They can finance additional artist and archivist engagements. And so much more.

Supporting ITMA's mission to universal access also benefits donors. ITMA will offer a number of sponsorship opportunities in 2025 that can see donors acquire naming rights to public exhibitions, artist- and archivist-in-residence spaces, and more. As we continue to upgrade and expand our production capabilities, ITMA can provide organisations and individuals with bespoke, broadcast-level film and promotional materials.

For those based in the U.S., donating to ITMA can be a tax efficient way of supporting our mission. ITMA is eligible for 501(c)3 donations and, working through the Ireland Funds and The Irish American Partnership, our donors have an amazingly positive impact on the work we deliver each year. For those based in Ireland, donors giving €250 or more can sign a CHY3 form, increasing the value of their donation by as much as 45%, at no additional cost. For example, with a signed CHY3 form, a €250 donation benefits ITMA to the value of €362.


### **Finbar Furey Collection**

In October 2024, ITMA staff made three visits to the Furey family home in Rathfarnham, Dublin, to acquire the extensive Furey Family Collection. Spanning material from the 1960s to the 2020s, the collection includes noncommercial audio cassettes, master reelto-reel tapes, CDRs, DATs, and VHS tapes, along with a rich array of ephemera such as programmes, posters, flyers, tickets, and newspaper clippings. Also included are numerous colour and black-and-white photographs, personal correspondence, and original song manuscripts written by Finbar Furey. This significant acquisition documents the career of one of Ireland's most prominent musical families, who performed internationally for decades, and adds to ITMA's growing archive of professional Irish musicians.

### **Musical Instrument Donations**

In 2024, ITMA received two donations of significant musical instruments. In May, Canon Gary Hastings donated a unique tin fiddle, handcrafted in 1984 by Simey Doherty of Ballyfeach, Co. Donegal. Commissioned by Robbie Haldane as a wedding gift for Gary and the late Caitríona Ní Ghallchóir, the fiddle was entirely made by Simey, who, in poor health, completed the instrument shortly before his passing. It stands as the last fiddle ever made by the renowned Doherty family.

In October, Elizabeth Bicker generously donated one of the harps belonging to her close friend, the late Derek Bell, with whom she frequently performed as a pianist. Wishing to honour his legacy, Elizabeth entrusted ITMA with the instrument, hoping it might be made available for public appreciation. The harp was transported from her home to ITMA's premises at Merrion Square, where it now joins the Derek Bell Collection already housed in the archive.

Donated by James & Helen Furey.

### **Audiovisual Collections**

### The Felix Dolan Collection

Felix Dolan (1937-2013) was for many years America's pre-eminent piano accompanist for Irish traditional music. Born in the Highbridge section of the Bronx, Felix developed an understated but always harmonically correct style and became the favoured accompanist of New York's Irish music and step-dancing elite, including Joe Burke, Andy McGann, Paddy O'Brien, Bobby Gardiner, Paddy Reynolds, Charlie Mulvihill, James Keane, Catherine McEvoy, amongst many others.

The Felix Dolan Collection was donated to ITMA in May 2024. The collection consists of non-commercial audio recordings primarily made in the north-eastern United States between the 1970s–2000s. The recordings feature Felix and associated musicians in a variety of settings ranging

from private rehearsal tapes to céilí, competitions and house parties. A small number of recordings given to Felix by other musicians are also included.

### Caoimhín Mac Aoidh Collection

Non-commercial audio collection, manuscripts, preparatory material for publication, photographs and correspondence, 1980s–2000s. Materials in the collection focus largely on Donegal fiddle music. Donated by Caoimhín Mac Aoidh.

# The Caroline and Michael Kilbane Collection

This website is a collection of just over 100 archival recordings made from live performances of Julia Clifford at her home in Thetford (Norfolk), sessions and other public performances, with PDF transcriptions of the tunes. The recordings were made by Michael and Caroline Kilbane on a Marantz cassette tape recorder at Julia's house during the period they lived in Ipswich, 1984–1987.

### The Phil Callery Collection

This collection consists of two deposits, containing over 200 audio recordings on cassette, CDR, Minidisc, and reel-to-reel tape. The recordings date from the mid-1970s until the 2010s. The subjects of the recordings vary greatly and include performances at festivals such as WCSS and Frank Harte, as well as concerts in various venues around Ireland. Voice Squad recordings and preparatory materials for commercial albums are also represented. Approximately 2 boxes of paper materials were also donated. These include commercial publications, music manuscripts, and other documents. Donated by Sarah and Rosa Callery.

### The Pat Campbell Collection

This collection is comprised of 23 reel-to-reels and 1 disc. Personal recordings of a variety of artists including Seán Maguire. Some recordings may have been preparatory work for commercial release on Silver Hill Records, 1970s. Donated by Pat Campbell.

# VHS to DigiBeta: Preserving Ireland's Intangible Cultural Heritage through Video Digitisation

In May 2024, ITMA was awarded €24,932 by the Heritage Council under its Community Heritage Grant Scheme. This funding has enabled the purchase of state-of-the-art video digitisation equipment and software, significantly expanding ITMA's capacity to play back and digitise thousands of video recordings held in its collections.

Thanks to the generous support of the Heritage Council, ITMA has established a new, in-house video digitisation suite in consultation with industry expert Adrian Finn. Without this facility, it would be impossible to properly view, preserve, and make accessible the wealth of video content already in ITMA collections. The digitisation suite is designed to capture archival-quality transfers of approximately 10 different video formats that are already held in ITMA's collections. For example, formats that can now be digitised in-house at ITMA include:

This enhanced capacity not only safeguards valuable audiovisual materials but also strengthens ITMA's mission to communicate, celebrate, and share Ireland's traditional culture and intangible cultural heritage with the wider public.

The evolution of technology makes highquality video recordings increasingly fast, easy, and inexpensive to create. As a result, ITMA predicts that video collections in a variety of formats will grow exponentially in the coming decade.

### **Internships**

As part of their MPhil in Digital Humanities and Culture at Trinity College Dublin, Qingqing Zhang and Chenbei Pan completed internships at ITMA. Qingqing explored the integration of IIIF players within WordPress platforms, while Chenbei focused on the presentation of interactive scores.

Ruth Flynn, a postgraduate student in Archives and Records Management at University College Dublin, completed her internship at ITMA in March 2024. During her time here, Ruth catalogued a collection of Tommie Potts manuscripts, generously donated by the Potts family in March 2024, creating a detailed archival record in AtoM. She also contributed to the organisation of the Cullen O'Connell Dance Collection, donated in October 2023.

From Maynooth University, Master of Arts in Musicology and Performance students

Marina Cabrera, Tyler Wallin, and Lina María Manjarrés completed a five-week placement with ITMA during February and March 2024. Their work focused on the Micho Russell tune transcription cards from the Breandán Breathnach Collection. The students digitised, indexed, and transcribed the music using notation software, and documented their experience in a blog post published on the ITMA website in April 2024.

### **Summer Internship Programme**

ITMA has developed a successful summer internship programme, now in its fourth year, that has seen the placement of 10 summer interns from diverse disciplinary backgrounds and educational institutions including Communications Studies, Information Science, Business studies, and Irish Folklore students from University of Notre Dame, University College Dublin, and Boston College.

ITMA's summer interns gain unique hands-on experience with our archival collections. This may include organising, describing, digitising, or making materials available to the public. Previous projects have focused on significant reel-to-reel collections and reorganising and inventorying disc-based media such as phonograph records and vinyl LPs.

This year's summer interns, Aubrey and Olivia Breen (Notre Dame) and Andrew Caden (Boston College), focused on reorganising ITMA's 78rpm phonograph record collection and developing and inventory of every disc held by ITMA.

ITMA houses one of the largest collections of 78rpm shellac records associated with Irish traditional music anywhere in the world. Recently ITMA carried out a complete inventory of its 78rpm disc collection. A total of roughly 10,000 discs were organised by record label and catalogue number, with all relevant metadata for each disc noted also.

The benefit of this work was transformative for the collection. Not only could we identify the total number of discs but also how many duplicates are present, how many disc require catalogue records, how many have been digitised or are yet to be digitised and finally, what discs ITMA

is missing. Although there is much work to be done to preserve these precious recordings, this crucial analysis will form the basis of future work on this collection.

With each box of 78s we catalogued and stored in the basement vault, was another 35 discs rediscovered-because now they have a location and pertinent info (such as artist names, tune titles, and instrumentation) recorded in ITMA's catalogue. Not only are all the 78s organized in alphabetical order by label and numerical order by catalogue number, but you can now look up any 78rpm record in ITMA's collection and find exactly where it is. 99



### **Culture Night with ITMA**

ITMA was delighted to host a series of six live performances of traditional music, song, and dance at our annual open house for the 19th edition of Culture Night on 20 September, 2024. The half-hour concerts, each attended by a different audience, featured both ITMA staff and musical guests.

Performing on the night were Róisín O'Connor (fiddle), Niamh Landale (uilleann pipes), Conor McKeon (uilleann pipes), Dermot O'Hanlon (fiddle), Iarlaith Mac Gabhann (flute), Seán Ó Broin (flute), Sophie Ryan (harp), Lúsaí Ryan (concertina), Andrew Caden (fiddle), Kyle Macaulay (guitar, bouzouki), Bridie Flaherty (dance), Nicole Ní Dhubhshláine (flute, concertina), and Méabh Ní Bheaglaoich (accordion).

All six concerts were at capacity, lending themselves to a night rich in culture and creativity across the island. Started by the Arts Council in 2005, Culture Night/Oíche Chultúir continues to provide special opportunities for people to dive into cultural events and unique spaces. More than 1.2 million people engaged with 1,700 Culture Night events in 2024, and ITMA looks forward to staging more great traditional artists in September 2025.

### **EA-DIGIFOLK**

ITMA are involved in this four-year research project, led by the University of Salamanca and funded by Marie Skłodowska-Curie Actions (MSCA). The aim of the project is to establish an open-to-the-public platform containing folk music from European and Ibero-American culture. ITMA hosted researchers from Spain and Portugal as part of EA-DIGIFOLK while Treasa Harkin visited Salamanca in Spain and Alan Woods went to Porto in Portugal to work on various aspects of the project.

### **Sparks from the Flagstones**

In February, ITMA hosted the official Dublin launch of dancer Edwina Guckian's Sparks from the Flagstones.

In the book, Edwina celebrates the folk traditions and calendar customs of the Ireland in which she grew up in rural County Leitrim. She dances through the Celtic Calendar Year and the importance of ancient Quarter Day customs and old-world Fire Festival traditions at Samhain, Imbolc, Bealtaine and Lughnasa.











### P.W. Joyce, Co. Limerick Educator and Collector

In October, ITMA hosted the official launch of 'P.W. Joyce and the Educational Shaping of the Emerging Irish Nation, 1827-1914', a book by Professor Teresa O'Doherty, Professor Tom O'Donoghue and ITMA CEO Liam O'Connor.

From Glenosheen, Kilmallock, Co. Limerick, Pádraic Weston Joyce was one of his generation's foremost educationalists and collectors of traditional Irish music. The influence Joyce's published works had on readers, teachers and journalists played a major part in shaping national thinking on historical and cultural aspects of Irish life in the years before independence.

The book was launched by Prof Kevin Whelan, Professor of Irish History and former Michael Smurfit Director of University of Notre Dame Dublin. The launch also featured music from the Joyce publications and manuscripts performed


by Laoise Kelly; Liam Flanagan and Ciara Flanagan, who run the annual Joyce Brothers Festival in Kilfinane, Co. Limerick; and Derek Hickey, who researched the music collections of Joyce for an upcoming Drawing from the Well episode. These artists are all helping to reintroduce tunes collected in the 19th century in Limerick to local school children, adult learners and musicians, singers and dancers.

Following the book launch, ITMA CEO Liam O'Connor performed and spoke at the 2024 Joyce Brothers Festival which celebrates the legacy and lives of P.W. Joyce and his brother and fellow music collector Robert Dwyer Joyce.

### **Hugh Shields Publications**

In 2024, ITMA was delighted to make two important books by Hugh Shields freely available on its website. In January, Narrative Singing in Ireland: Lays, Ballads, Come-All-Ye's and Other Songs was published online, followed in September by All the Days of His Life: Eddie Butcher in His Own Words along with its three accompanying CDs.

ITMA would like to sincerely thank the Shields Family for their kind permission to make these valuable resources accessible to the public.

## Journal of the Irish Folk Song Society

In March and April 29 volumes of the Journal of the Irish Folk Song Society (1904–1939) were made freely available on the ITMA website. The Irish Folk Song Society (IFSS) was founded in London in 1904. The object of the Society was 'to collect all the unpublished traditional airs and ballads of the Irish race, and to print and publish as many as possible from time to time'. This was accomplished through the publication of a journal.

## The Moynihan Dance Manuscript

In August 2024, ITMA published *The Moynihan Dance Manuscript* on its website. This unique document contains the unpublished typewritten notes of a 1938 interview with Mr James Moynihan, a well-known dance master from Cork City. The manuscript was donated to the Cullinane Archive Collection (CAC) by Mrs Peggy Barry of Cork City, who had been a pupil of Moynihan in her younger days.

# Stories Told by Cards & Tapes: Uncovering Denis Murphy Materials at ITMA

This online project, curated and edited by fiddle player Anton Zille, shines a light on the musical legacy of Denis Murphy through the rich resources of the Irish Traditional Music Archive. Published on ITMA's website in November 2024, the project was undertaken to mark the 50th anniversary of Denis Murphy's untimely passing in 1974.

Presented across nine chapters, the project features curated playlists and images of *An Cnuasacht Iomlán den Cheol Damhsa* (CICD) index cards from the Breandán Breathnach Collection. In total, 38 audio tracks and 39 CICD cards are showcased.

Six of Denis Murphy's tunes have been transcribed in detail by Anton Zille and are available as interactive scores synced to the original recordings. These are also offered as downloadable PDFs and in ABC notation format.

ITMA gratefully acknowledges Anton Zille's valuable contributions to this project.

#### Misleór 2024

In 2024, ITMA collaborated with the Misleór Festival of Nomadic Cultures to make a rare and out-of-print album of Traveller stories and songs freely available through the ITMA website. The recordings originally published on cassette as 'Stories and Songs of the Road, vol. 1' were made by Niall Ó Murchadha with Travellers based in Co. Galway between 1989-1991. As part of the Misleór 2024 festival programme, ITMA co-hosted an event celebrating the audio collection, which brought together the families of the performers featured in the recordings.

### Ireland's Whistling Ambassador: Micho Russell

The 30th Anniversary of the death of Micho Russell was also remembered with the publication of Bill Ochs' film *Ireland's Whistling Ambassador'*. Along with the film, ITMA published interactive transcriptions of Micho's tunes and added two commercial CDs of Micho Russell's music through his Pennywhistler's Press to ITMA's shop. ITMA would like to thank Margaret Vetare and the Moloney and Russell families for permission to reproduce the material

Other material added in 2024 included a new series of ITMA video interviews; photographs from Des Gallagher and a further 59 interactive scores.

Work continued to bring the remaining material from the previous website into the new design, including the Dusty Bluebells microsite, Furls of Music microsite and 2,000 compositions by Andy Dickson. The Goodman and Grier manuscripts were also re-published in a new IIIF interface.

#### The Old Reels of the World

In July, ITMA launched a new album of outstanding, previously unheard recordings of traditional music and song from its collections. The Old Reels of the World features 21 tracks from the donated private collections of Tom Davis, Tony MacMahon and Larry Redican. The CD was compiled by Prof Pádraic Mac Mathúna and formally launched at Scoil Samhraidh Willie Clancy 2024 by former ITMA chairperson Cathal Goan.

The album features recordings dated from the 1950s to the late 1990s from some of the biggest names in traditional music, including Séamus Ennis, Willie Clancy, Bobby Casey, Joe Heaney, Leo Rowsome, Kathleen Harrington, Tommie Potts, Seán Keane and more.

Prof. Pádraic Mac Mathura is an uilleann piper and retired gastroenterologist, who over the past three years has catalogued a huge body of old recordings for ITMA pro bono. His father, Ciarán Mac Mathúna, worked as a radio and TV presenter for RTÉ, and for decades collected Irish traditional music throughout Ireland and during trips to the United States. Ciarán also sent private personalised recordings to musicians in the States, some of which have been catalogued by Pádraic during his time with ITMA.

### St. Brigid's Day

On 1st February, for the third year in a row ITMA presented a composition on the theme of St Brigid to mark her national holiday. The composer this year was Sandie Purcell, a fiddle player and primary school teacher from Kill, Co. Kildare.

In 2024, ITMA continued the 'Pádraic's Picks' web series — a monthly playlist from the collections of Tom Davis, Tony MacMahon and Larry Redican curated by Dr Pádraic Mac Mathúna.

# Cathal and Maura McConnell Collection Playlists

Cathal McConnell, renowned musician and singer, donated 700+ cassette tapes to ITMA in 2023, a vast collection that spans more than four decades from the late 1960s to the early 2010s. His late sister Maura's collection was donated to ITMA in 2002 and contains over 400+ non-commercial audio tapes, photographs, printed materials and features recordings from the 1960s–1980s.

The non-commercial audio material was recorded both in Ireland and abroad in a range of settings including field recordings in houses, informal sessions, concerts, outtake studio recordings, music classes and workshops. Cathal cast his musical net far and wide and listeners can enjoy an informal gathering in a kitchen in rural Fermanagh before being transported to stages from New York to Melbourne. This reflects Cathal's life as a performing musician who maintained a steadfast link to his native tradition.

In 2024, Donegal fiddle player Rónán Galvin curated six playlists for ITMA's website that explored this treasure of traditional music and song. This project was made possible thanks to funding from the Arts Council of Northern Ireland.

### **December in-house Field Recordings**

In December 2024, ITMA conducted nine field recording interviews in the library at 73 Merrion Square with a collection of traditional musicians, singers and dancers. Over the course of three days, ITMA interviewed 10 different artists: fiddle player and collector Caoimhín Mac Aoidh, singer Len Graham, dancers Bernie Nic Gabhann and John Murphy, dancer Cuthbert Tura Arutura, dancer Terry Moylan, singer Nan Tom Teamín, singer Gearóidín Breathnach, fiddle player and singer Mairéad Ní Mhaonaigh and composer Bill Whelan. The interviews were conducted by Liam O'Connor, Ciarán Ó Maonaigh, Síle Denvir and Caitlín Nic Gabhann and Edwina Guckian.

### Taoscadh ón Tobar

ITMA's flagship artistic series "Drawing from the Well" launched in 2020 with the aim of connecting Ireland's leading traditional musicians, singers, and dancers with ITMA's rich archival material to inspire new works of art. In May 2024, in partnership with TG4, this concept was brought to the small screen in Taoscadh ón Tobar.

The docuseries brought Ireland's traditional music to life and uncovered the stories of significant musicians, singers, collectors, and regions over the course of five episodes. Italian-born fiddle player Andrea Palandri traced the life and music of Sliabh Luachra fiddle master and teacher Pádraig O'Keeffe. Cúil Aodha native Iarla Ó Lionáird studied the songs of his locality as collected by Alexander Martin Freeman in the early 1900's. Doireann Ní Ghlacáin uncovered the story of fellow Dublin fiddle player Bridget Kenny, dubbed "The Queen of Irish Fiddlers" by Captain Francis O'Neill. Seán McElwain highlighted the music of Sliabh Beagh, a border area where counties Tyrone, Fermanagh, and Monaghan meet. And singer Muireann Nic Amhlaoibh performed a deep dive on the songs of Seán de hÓra, a standard bearer of the tradition, and the only ever Oireachtas winner to hail from Corca Dhuibhne. The programme was broadcast over five weeks on TG4 and is now freely available via the TG4 Player.

## Brendan Gleeson's Farewell to Hughes's

Brendan Gleeson's Farewell to Hughes's, a documentary co-produced by ITMA and actor Brendan Gleeson, made its world premiere at the 2024 Dublin International Film Festival on Friday, 1 March, 2024. The film, directed by Ciarán Ó Maonaigh and presented by Brendan Gleeson, explores the music and legacy of Hughes pub in Dublin.

After its DIFF premiere sold out within 24 hours, the film had a three-month run at Dublin's Light House Cinema and Galway's Pálás Cinema. In the Autumn, the film made its international debut in Sydney, Melbourne, Perth, Brisbane and Canberra as part of the Irish Film Festival Australia. Following this, Aer Lingus acquired the rights to air the film on board its in-flight entertainment system. In December, the film made its broadcast debut on TG4, with plans to air on Sky TV in the UK and Ireland, SBS in Australia and the Rialto Channel in New Zealand 2025.

Farewell to Hughes's was awarded Best Documentary at the 2024 Vancouver Movie awards and was nominated for the George Morrison Best Feature Documentary at the 2025 Irish Film and Television Academy (IFTA) Awards.

66 Brendan Gleeson's Farewell to Hughes's is a succinct feature documentary made by Ciarán Ó Maonaigh and produced and presented by Brendan Gleeson - both accomplished musicians in their own right. To those uninitiated in traditional music, the lack of an introductory narrative may leave them curious to where it is headed. However, the story unfolds slowly to reveal a hidden world of music, song and dance. 99


### **Drawing from the Well: Junior**

### **Presentations & Publications by ITMA Staff**



### **The Pigot Collection**

In late November, ITMA published an important new collection of more than 600 transcriptions of pre-Famine Irish traditional music.

The Pigot Collection: Irish Traditional Music from the John Edward Pigot Manuscripts features staff-notated music collected in the 1840s and 1850s by the barrister-at-law and amateur musician John Edward Pigot, assisted by his musician wife Annie Prendergast.

The book, edited by ITMA Director Emeritus Nicholas Carolan and Caitlín Uí Éigeartaigh, features all the melodies Pigot noted from live performance and from manuscripts given to him by friends and colleagues. These are featured along with essays on the collector, illustrations, appendices and indexes. The Pigot Collection is a companion to ITMA's Forde Collection, published in 2022.

Throughout 2024, ITMA Archivist Maeve Gebruers delivered a number of presentations to a range of audiences, sharing expertise in traditional music archiving and digital preservation.

On 6 March, Maeve co-presented with ITMA Digital Librarian Treasa Harkin to students of Traditional and World Music at the University of Limerick. Other

engagements included a presentation at the Heritage Week Training Day in Limerick (16 May), and participation in the National Library of Ireland/Digital Preservation Coalition (DPC) event on digital preservation systems (25 September). In November, Maeve spoke at the Exploring Archival Cataloguing event at Dublin City Library & Archives, organised by the Irish Archives Resource, the Archives and Records Association, Ireland, and UCD School of History. Earlier in the year, she was also one of three invited guests on the Archives & Records Association's Archive Hour Twitter discussion (March), focusing on the challenges of archiving intangible cultural heritage, alongside Dr Barry Houlihan (NUIG) and Lisa Shorthall (Heritage Council).

Treasa Harkin gave an interview to Raidió na Gaeltachta about a cassette tape and essay by Niall Ó Murchadha entitled 'Stories and songs from the road', recordings collected from Irish Travellers in Galway, 1989-1991, which was re-published on the ITMA website.

Treasa Harkin's article Interactive Scores at the Irish Traditional Music Archive was published in Fontes Artis Musicae, Vol. 71, No. 3

### **Margaret Barry research**

At Scoil Samhraidh Willie Clancy 2024, ITMA's Field Recording Officer Alan Woods presented a lecture on the life and music of the Cork born singer, Margaret Barry. Alan undertook a period of extensive original research that saw him conduct field recording interviews with members of Margaret Barry's family and people who knew and played music with Margaret such as Reg Hall and Paddy Joe Tighe. Through Alan's research, a number of donations and new collections were added to the ITMA Collection, including rare video footage of Margaret filmed by Winston Pettus, audio donated by Roger Digby and a mixed media collection loaned for digitisation by Antoinette Keane that includes audio, photographs and a manuscript of music written by Margaret Barry's musical partner, Michael Gorman.




### **Arts Council Strategic Funding**

In 2024, ITMA's annual strategic funding from the Arts Council of Ireland/An Chomhairle Ealaíon was at a standstill of €950,000. In providing a free public service and established on a not-for-profit basis, ITMA is dependent on the financial support of its main funding institutions and was extremely grateful in the confidence shown by the Arts Council of Ireland/An Chomhairle Ealaíon in sustaining a high level of financial support for ITMA in 2024.




### **Other Funding**

ITMA was awarded annual funding of £23,450 by the Arts Council of Northern Ireland. The Heritage Council awarded funding totalling €74,932 from two separate grant streams in 2024. In-kind benefit was received from the State through a rental agreement with the Office of Public Works for its premises in 73 Merrion Square. In 2018 this was valued at an in-kind income of €140,000. ITMA received philanthropic donations worth €167,530 as of 31st December. ITMA are grateful to our other grant funders.




### ITMA Funding 2023



### **Online Shop**

### **ITMA Reserves Policy & Plan**

The following was agreed at the ITMA Board Meeting on 12/12/2023: The audit committee recommends a policy of creating 4 months reserves by the end of 2024, 4.5 months reserves by the end of 2025, and 5 months reserves by the end of 2026.

- The level of Reserves held by the organisation are to be monitored on a monthly basis by ITMA's accountants and Director/CEO and on a bi-monthly basis by the Audit Committee and the Board
- ITMA's accountants prepares a specific Reserves calculation as part of each management accounts pack
- ITMA Finance & Administration staff are subject to expenditure approval limits as set out in the company's Financial Management and Procedures Manual
- The Chair of the Board signs off on all yearly budgets submitted to the Arts Council as part of the annual application for strategic funding
- Company expenditure levels vs budget are reviewed monthly by the Director/CEO and bi-monthly by the Audit Committee and Board.

#### **Use of Reserves**

Company reserves may only be utilised in the following circumstances:

- Expenditure items are "revenue generating", i.e. shop stock items
- Expenditure items are exceptional in nature, in the best interests of the organisation and must be approved by Director and Chair of the Board.

### **Building Reserves - Plan**

ITMA plan to grow the financial reserves of the Company by the following means:

- Increasing ITMA Shop Income
- Increasing donations income and philanthropic support via ITMA's matched funding scheme
- Increasing ITMA "Production" Income
- Developing new private/fundraising income streams, i.e. ITMA studio space & ITMA Content Income.

### Principal Risks and Uncertainties

The directors are responsible for the company's system of internal controls and for reviewing its effectiveness. The internal control system is designed to manage, rather than eliminate the risk of failure to achieve the company's business objectives and can only provide reasonable and not absolute assurance against material misstatements or loss.

The directors are not aware of any specific risks or uncertainties which would have an impact on the company. The company plans to improve its present activities and current trading levels. Employees are kept as fully informed as practicable about developments within the business.

Risk Register identifies risks under the following themes: Governance, Strategic, Legal and Regulatory, Operational Financial, Environmental & External and Reputational.

The following key risks were identified in 2021 and continued to be a priority in 2024:

- IT Obsolescence, security and upgrade
- Data asset storage and preservation capacity

- Mitigation measures have been put in place to reduce the risk level.





#### **Ethos**

ITMA is committed to operating to the highest standards of good governance practice. ### **Structure & Management**

ITMA is a company limited by guarantee, registered under Part 18 of the Companies Act 2014. The company was established under a Memorandum of Association which established the objects and powers of the charitable company and is governed under its Articles of Association and

managed by the Board of Directors. ITMA Board sub-committees are established for good governance practice. ITMA has three board subcommittees, Audit & Finance, Governance and Fundraising who report to the Board at each board meeting. These subcommittees comprise of industry experts in the field of business management, finance, governance, law, information technologies and media. ITMA have a dedicated Governance Officer on staff who works closely with the CEO and Administration in reviewing company policies and procedures before reporting to the Environmental, Social and Governance (ESG) Committee. ITMA governance policies and procedures are reviewed and updated periodically by the Environmental, Social and Governance (ESG) Committee throughout the year.

## **Appointment of Directors & Induction**

Board members are recruited in accordance with the Board Competency Framework. This document is part of the Board Member's Handbook and comprehensively sets out the recruitment process. Nicky Phelan. A graduate of 'Leadership For Growth' executive education programme at Stanford University in Palo Alto, California. He has studied child psychology and is an honorary Fellow of IADT National Film School. Cathal was nominated for the Ernst & Young Entrepreneur of the Year programme and has won an Emmy, a Peabody Award and the Murakami Award at Dingle Animation.


## Delegation of Board Responsibilities to the Director of ITMA

The Board of Directors is ultimately responsible for ITMA. Article 84 of the Articles of Association provides that the directors may delegate any of the powers which are conferred on them and the following duties and responsibilities have been delegated to the Director/CEO:

**66** To implement the strategic plan, and to lead and manage ITMA's staff members, programmes, projects, finances, pricing and all other administrative aspects so that ITMA's ongoing mission, vision, and strategies are fulfilled within the context of ITMA's values as approved by the Board of Directors. The Director/CEO shall have responsibility and authority over all areas of the organisation including any subsidiaries. The Director/CEO is also responsible for preparing materials for Board consideration and for preparing materials for any future strategic planning process. ">>

(ITMA Handbook for Board Members, p.14 (2020))

The Director/CEO's responsibilities for contracts and leases, staff appointments, business records, financial matters, financial supervision, receipt of funds, disbursement of funds, financial records are outlined in ITMA's Handbook for Board Members. The Director/CEO prepares an Annual Strategic Yearly Plan informed by ITMA's Strategy 2019-23, which outlines strategic, committed projects, milestone events, business as usual and other priorities broken into quarterly goals. The Annual Strategic Plan is presented by the Director/CEO for Board approval and reported on subsequently at every Board Meeting. The Director/CEO's performance can be measured by the delivery of the Annual Strategic Plan.

## **Staff Performance KPIs and Remuneration**

The Director/CEO bases each individual staff members' KPIs on the Annual Strategic Plan's organisation-wide goals which is reflected in the respective individual's yearly performance plan. These personalised plans also make reference to resources needed, training available, and assessment markers and are agreed with staff input. Individual performance plans are outlined and discussed with staff in a formal meeting in early Q1 with quarterly informal discussions, half-yearly reviews and formal year-end reviews.

ITMA's remuneration for staff is guided by ITMA's Salary Scale operative since 1 September 2008 which is a 13 point scale ranging from €26,750 to €54,994.
