Summary of Distribution
- Where was the distribution held and how was it organized?

-What and how were beneficiaries informed? - How was equal access ensured for men, women, girls and boys? - How was order maintained during the distribution?
• Distribution was held on 18 August 2014, for 124 HHs and 573 individuals. • Beneficiaries were all mobilized by RRC enumerator before the day of distribution, to make sure all of them have access to information. • During distribution, only two names of the beneficiary were called, then the last name is completed by the owner. This is done to reduce the confusion of those who have the same names and people not registered and striving to receive but have not been registered on the list.
What actors were involved in the decision-making regarding the distribution process? -Explain what role the following people had in the process: local authorities, partners, humanitarian officers, volunteers, beneficiaries, etc.
• No much process was done during distribution as the information gets them on time which makes distribution work successfully. • All beneficiaries who were verified and registered for the needs have received assistance.

No changes occurred to the original distribution plan

124 HHs conflict IDPs from greater Upper Nile verified by IOM/RRC were all considered and received assistance of NFI full kits and loose items according to their household size.

No challenges encountered because distribution was carried out at RRC office & same Households affected by the conflict & reported by IOM/RRC receive same supplies of NFIs.

The findings indicate that the recently population of IDPs have never received any assistance apart from NFI kits although they only get limited hand-out from the community, they state that shelter should be a priority especially this period of rain to avoid malaria & other diseases breakout, follow by food which responsible cluster have taken note on.
