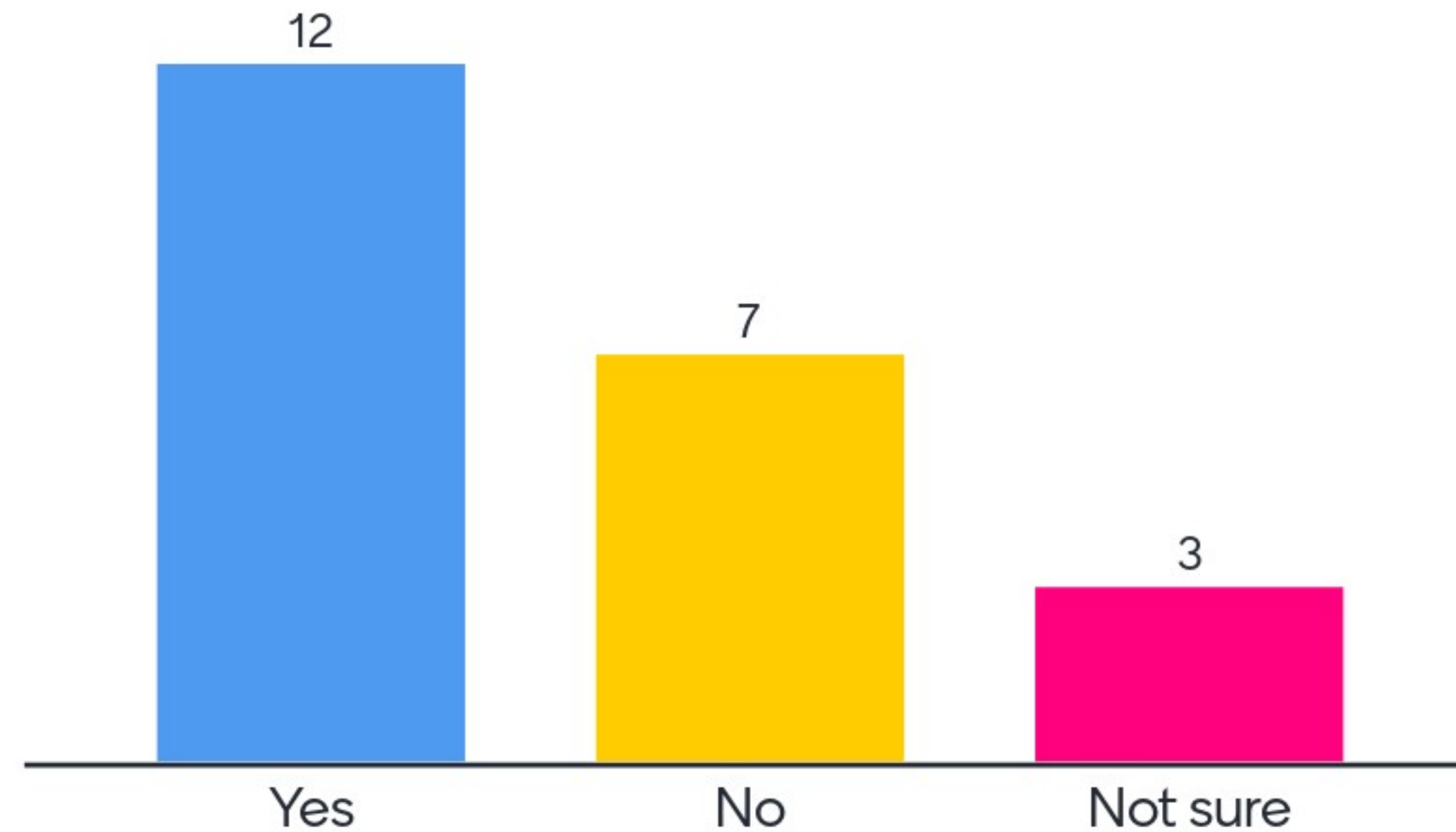
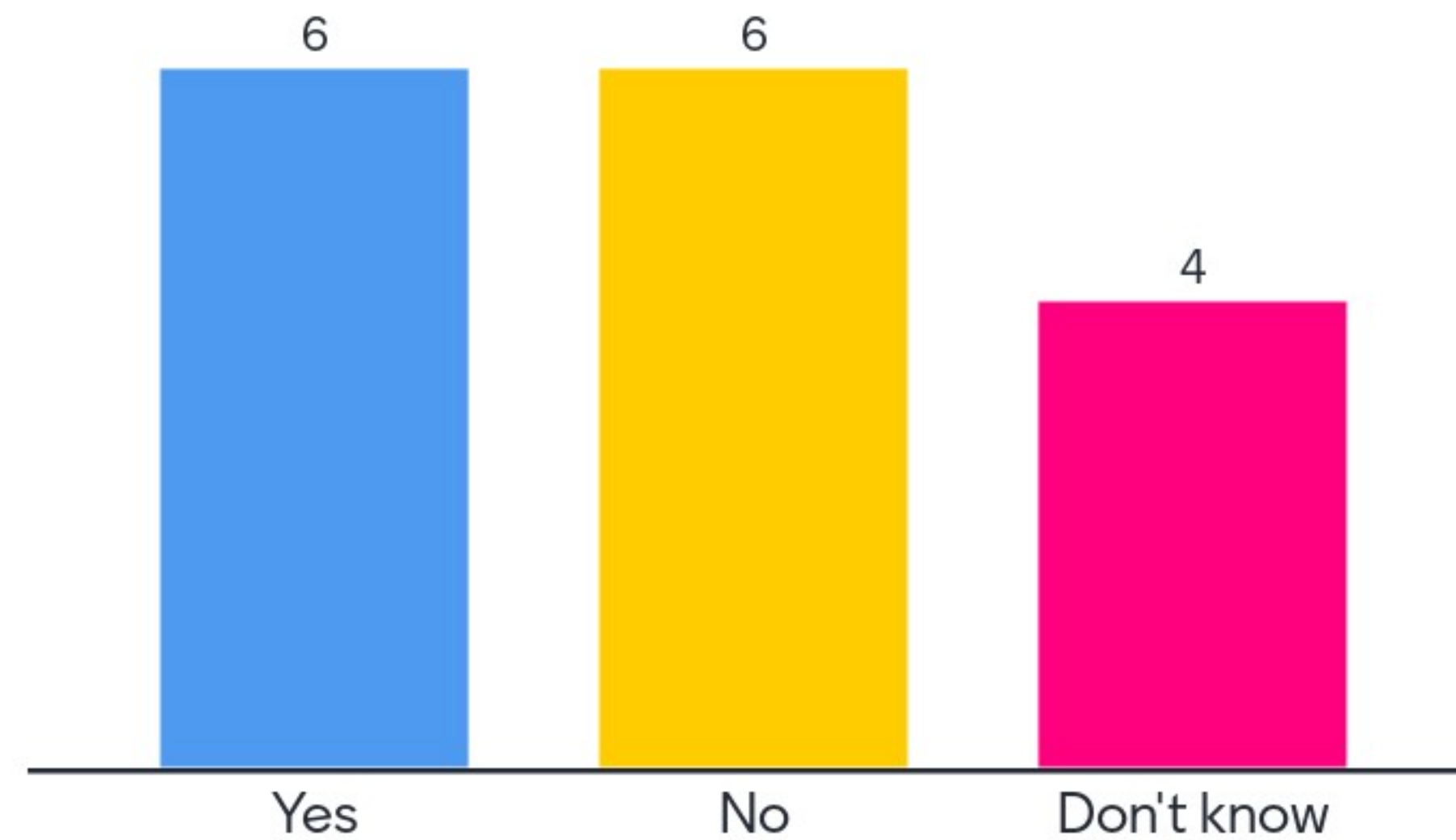


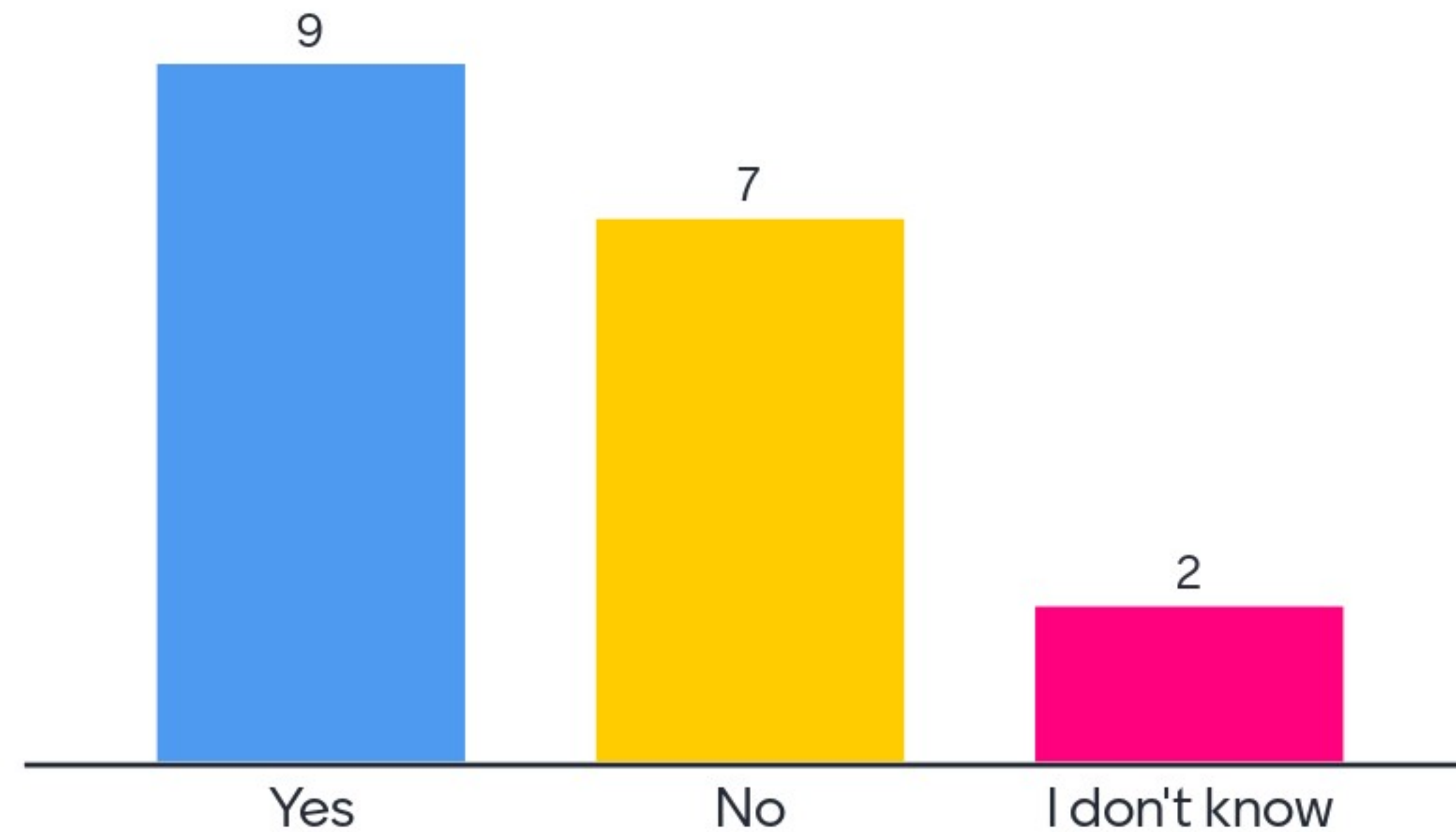
# Q1 - Is Area-based Coordination present in the country you are working on?



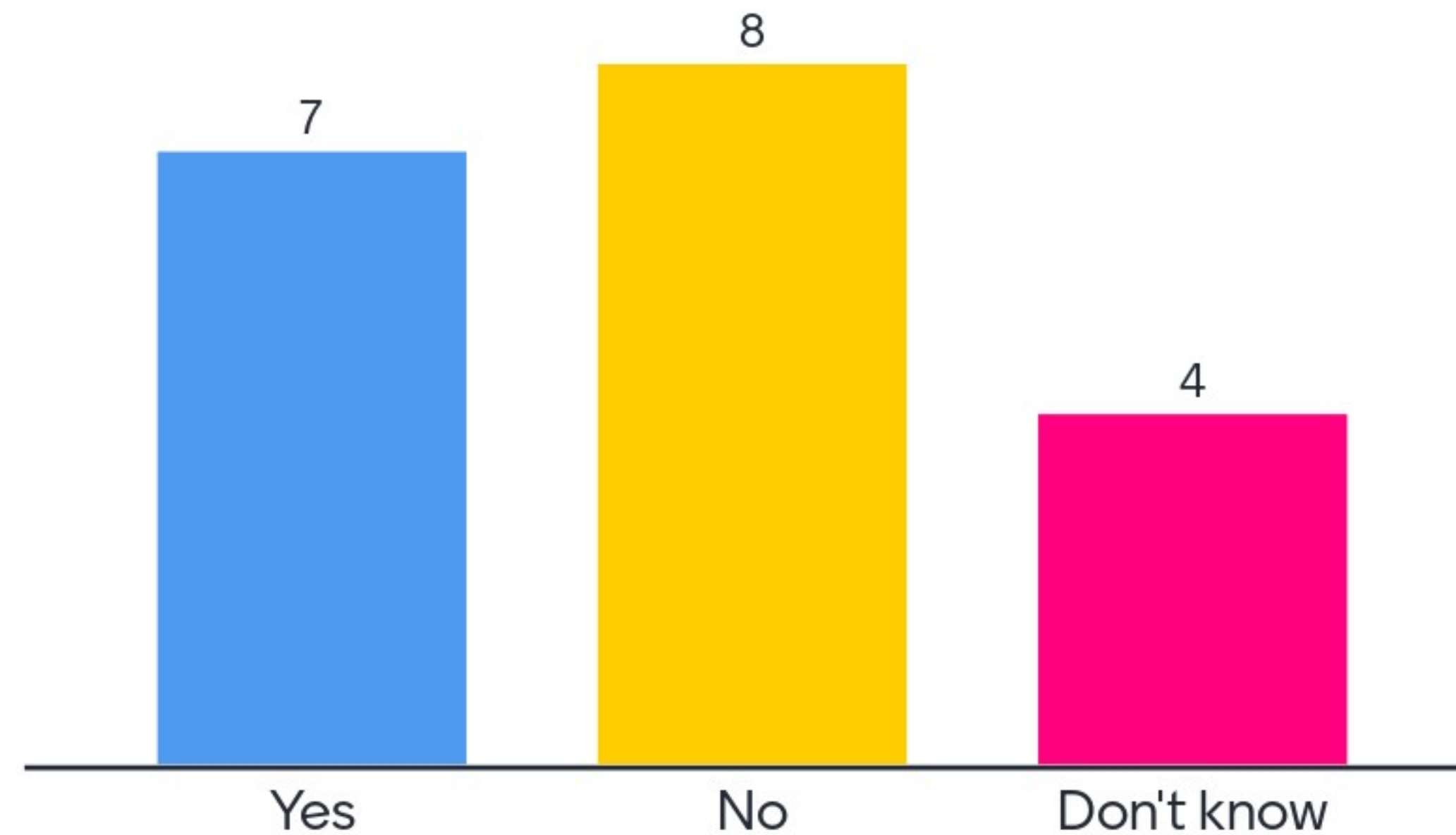
**Q2 - If answer to Q1 is yes or to some extent: Is the Shelter Cluster actively engaging and collaborating with(in) the ABC structures?**



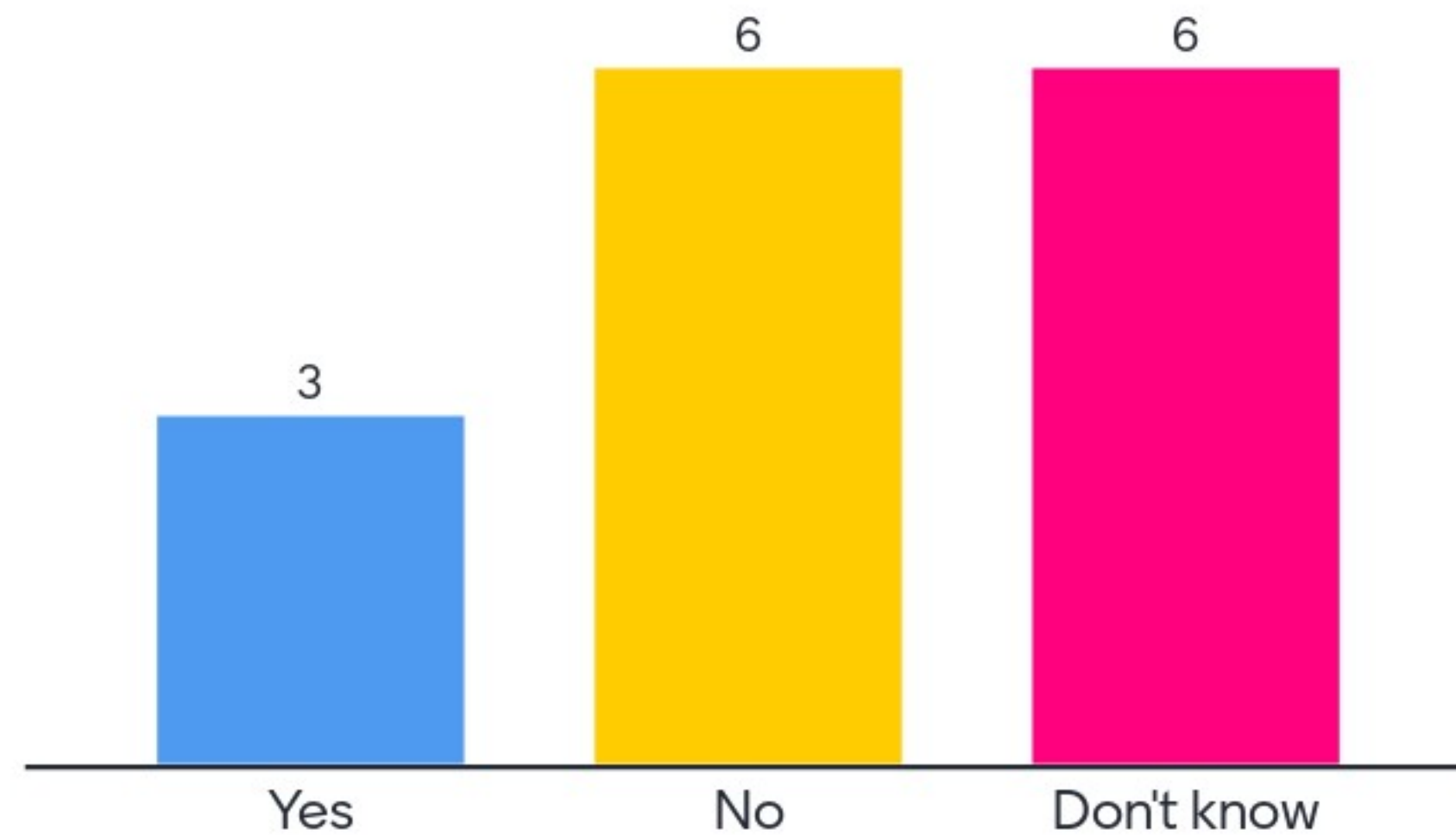
# Q3 - Has this topic been recently discussed at ICCG level in your country?



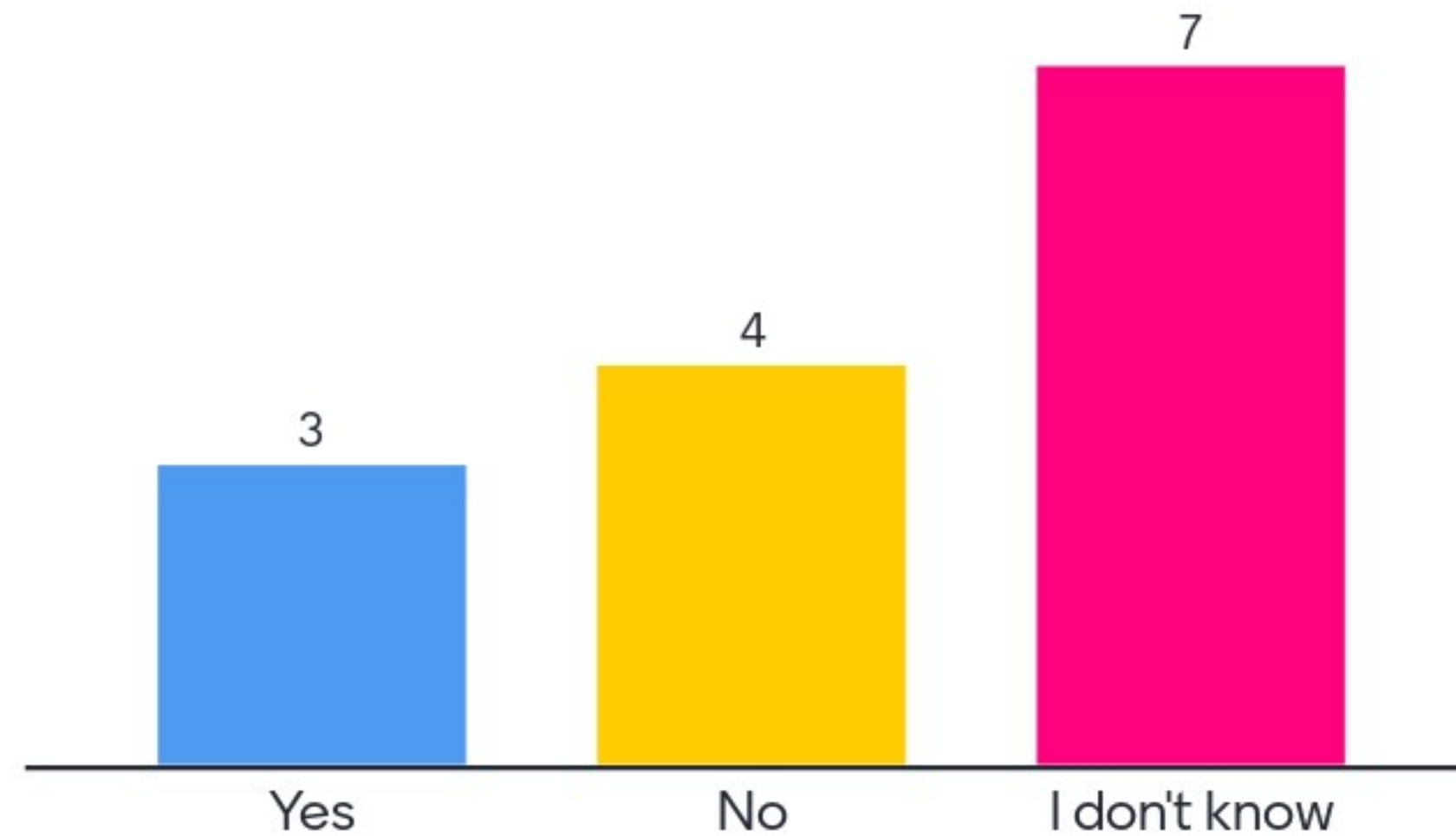
# Q4 - Has this topic been recently discussed by the heads of agencies?

# What could be done regarding this topic at global level to support your work? (actions at global level)

To build consistency on understanding of Shelter sector ABC /ABA more discussion platform/case studies of sharing could plan

drafting clear guidance on ABC at Global ICCG level

GSC should take an active role in the discussion on the ERC initiative in the countries where ERC Flagship is launched

Clear guidance

Prepare a position paper guiding county level clusters  
Consolidate a position with UNHCR tri-cluster
