2021 FIA WTCR – RACE OF GERMANY

The Stewards have received, on 3 June 2021, a request from the following Competitors concerning all Hyundai Elantra N TCR Cars:

- 1) BRC Hyundai N LUKOIL Squadra Corse / Cars # 3 & 5
- 2) Engstler Hyundai N Liqui Moly Racing Team / Cars # 8 & 69
- 3) Target srl / Cars #19 and 26


The request of the Competitors concerned follows a request made by Mr. Andrea Cisotti in his capacity as Customer Racing Development Engineer for Hyundai Motorsport.

Mr. Cisotti has asked the Stewards for "the permission to use only the driver wiper blade during the 1st round of WTCR in Nürburgring". Mr. Cisotti has mentioned in his request that during a recent test, Hyundai Motorsport has discovered an issue with the wipers as they do not function correctly above 200 kph. In such a short time, all the attempts to solve the problem were unsuccessful. Hyundai Motorsport has requested permission for WTCR Round 1 in Nürburgring to remove the passenger side blade as that at least allows the Driver side to work properly.

After having spoken with the FIA Technical Delegate about the solution proposed by Hyundai Motorsport, the Stewards have decided to allow Cars concerned to compete in Nürburgring only in these conditions due to the characteristics of the circuit and to the weather conditions.

This decision has been taken in accordance with Art. 11.9.2 a) of the FIA International Sporting Code, which gives authority to the Stewards to settle any matter which might arise during an event subject to the right of appeal provided for in the Code.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards in accordance with Art. 15 of the FIA International Sport Code and Art. 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
