
## 2021 FIA WTCR – RACE OF CZECH REPUBLIC

**From** The Stewards **Decision N° 32**  
**To** The Competitor's Representative  
BRC Hyundai N LUKOIL Squadra Corse

The Stewards, having received Report #10 from the FIA Race Director, reviewed video evidence, heard from the Competitors' Representatives and Drivers concerned, considered the following matter, and determine a breach of the regulations has been committed by the Competitor named below and impose the penalty referred to.

**No / Driver** 5 / N. Michelisz  
**Competitor** BRC Hyundai N LUKOIL Squadra Corse  
**Session** During Race 1  
**Time** 14:22  
**Facts** On the course of lap 1 approaching Turn 1, Car #5 made contact with the rear of the Car #100 who subsequently collided with Cars #222 and #17 who were in front of him. Cars #222 and #17 stopped in the run-off area and the safety car had to be deployed.  
**Offence** Breach of Art. 17.1 d) of the 2021 FIA WTCR Sporting Regulations  
**Penalty** **Drive Through penalty converted into a time penalty of 30 seconds added to the total elapsed time of the Car concerned in Race 1 of 2021 FIA WTCR Race of Czech Republic** in application of Art. 17.3 i) and Art. 19.1 of the FIA WTCR Sporting Regulations and Art. 11.9 of the FIA International Sporting Code.  
**2 penalty points (2 in total)**  
**Reason** After evaluating all of the information and possible evidence, the Stewards found that the Driver of Car #5 was responsible for causing the collision. This decision has been taken in accordance with application of Art. 11.9.3 a) and Art. 11.9.3 h) of the 2021 FIA International Sporting Code and Art. 2 d) of Chapter IV, Appendix L of the 2021 FIA International Sporting Code.

Competitor is reminded of the right to appeal certain decisions of the Stewards in accordance with Art. 15 of the FIA International Sport Code and Art. 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
