SECTION 4: First-aid Measures

4.1 Description of First Aid Measures

GENERAL NOTES: Show this safety data sheet to the doctor in attendance.

AFTER INHALATION: Move to fresh air. Give oxygen or artificial respiration if needed. When risk of unconsciousness, place and transport the victim in secured recovery position. 4.2 Most important symptoms and effects, both acute and delayed

Harmful by inhalation. May cause sensitization by skin contact. Danger of serious damage to health by prolonged exposure. Irritating to eyes, respiratory system and skin. Vapours may cause drowsiness and dizziness.

Carbon Dioxide, Dry Chemical, Foam

5.2 Special hazards arising from the substance or mixture

Fire will produce dense black smoke containing hazardous combustion products (see section 10). Heating or fire conditions liberates toxic gas. Flash back possible over considerable distance. Precautions for safe handling
