- Implement and maintain an effective Quality Management System according to the requirements of the UNI EN ISO 9001 standard, systematically updating and applying the defined procedures and prescriptive documents as an aid provided to the organization; extend the Quality Management System to the additional requirements of the Automotive industry in accordance with the IATF 16949 standard and of the Medical sector in accordance with the UNI EN ISO 13485 standard as defined by the organization;
